ADA Accessibility	ADA seating is available in Row A of all sections. ADA parking is available onsite and is on a first come first serve basis.
Address	11000 Telegraph Road, Glen Allen, VA 23059
Animals	Animals, except for service animals, are prohibited inside the building.
ATMs	The HSEC does not have the ability to process cash payments.
Baby Changing Stations	Changing stations are in each Family Restroom.
Banners/Signs/Flags	Posting or displaying banners/signs/flags requires prior approval from ASM staff. If signage is approved, it may only be displayed in designated areas. Signs that are offensive, vulgar, or commercial in nature will not be permitted inside or outside the facility.
Bag Policy	Staff reserves the right to check all bags that enter the facility. Please see the "Know Before You Go" page for your event's specific bag policy.
Box Office	Please see the "Know Before You Go" page for your event's specific ticketing policy.
Cameras	Video recording or photography is not allowed except in designated areas. Tripods cannot be used without prior approval.
Catering	Catering can only be provided by ASM.
Children's Tickets	Tickets for children are dependent on the event organizer protocols. Please see the "Know Before You Go" page for your event's children's ticket policy.
Concessions	Guests cannot bring in outside food or beverages. One empty, refillable container will be permitted to use at the various water fountains. Concessions will be available to guests for any large-scale event or in- house programming. Catering will be provided at request only through ASM. Vending machines are located inside the building. Alcohol will be available for purchase for guests 21 and older with valid ID at certain events.
Credit Cards	Only credit cards are accepted for concessions and box office payments. Staff are not capable of processing cash payments.

Drones	Drones are not permitted inside or outside the building.
Elevators	Elevators are located on both sides of the court.

Firearms/Weapons	Firearms or weapons are not permitted inside the building.

Guest Conduct	Guests should always display courtesy, impose self-control, and abide by HSEC policies. Spectators should remain in the spectator area and will not have access to or speak to any official, coach, or player during game play. Inappropriate and disrespectful language or signage is not tolerated. No guest may kick, throw, or hit balls or other items against the wall (interior or exterior) except on courts during warm-up or game play. Those engaging in any athletic activities must follow the <u>Code of</u> <u>Sportsmanship</u> .
