- The Interior doesn't have too much to report at this time. Presently, most associations are continuing to run Winter Ball Programs, which will conclude early on in March.
- As this concludes, focus will move to tryouts for the 15U & 18U AA/AAA teams, which are scheduled for late February through March. This year, we expect to have 2 15U AAA teams, and 4 18U AAA teams in the interior.
- The Spring Interior Meeting is set for March 4th at the Sandman Inn in Kelowna at 11AM.

7.9 Web Site – Tom Katelnikoff

- Over the last month, we had a request from Chemainus to change the boundary between Chemainus & Duncan. We did not receive an official change at the AGM, but in speaking with both associations, the boundary is mutually agreed between the two and the changes to reflect this have been made.
- I also received a request from an association to post an article on the website. If we do this for 1 Association, we would have to do it for all associations. The solution I came up with was to create an Association Baseball News page located in the top navigation under Associations. This could be a place for

us to post any association news from all of our 50+ Associations. Also a place where people could go to see what is happening in other associations.

- TeamPages has created a Mobile App for both Android & iOS, which is available in the Google Play Store &
 Apple App Store. It creates a streamlined feed of news from associations of your choice, which if
 implemented properly could provide a great way to communicate better with our audience.
- The document that has our association affiliation numbers and our letterhead and other private board documents are available in the executive member areas. Due to the season rollover it is necessary for me to resend all board members an invitation to join that private section of the website. If you have a profile already set up on our website, simply accept the invitation I have sent you. If you have not set up a profile with Teampages, now is the time to do it, it only takes a couple minutes. If you have any problems, just let me know.
- We have over 42 Tournaments listed in our Tournament page, John Braaten has been posting them.
- We have built up our Facebook following after having our page unexplainably deleted. At that time, we
 had nearly "Likes" on our page. This past weekend, with the activity we posted and a small promotion we
 were able to add 32 "Likes" and create a fair amount of activity on the page. The plan is to keep the
 interest going with regularly posted articles. Please send me anything that you might have for content to
 post.
- Fair amount of interest has been generated recently on Twitter. We have nearly 300 followers and have seen an increase in activity with our recent tweets about the island coaching convention. Again, we will be posting information at the BC Baseball Coaches Convention, which should generate more interest.
- Please continue to send me any dates or updates for the master Calendar on the website.

Point 1

On the point of promoting or advertising businesses, such as free information sessions or posting a link that leads to signing up for different camps, clinics, scholarships, selling books, videos or any business or endeavor that is for profit, I am opposed to at this time for the following reasons:

- By doing this it could/will give the impression BC Baseball endorses this endeavor or another company that does the same thing.
- Our website has value both by that fact that we have in excess of 17,000 players who are likely to visit our site and also, their parents, relatives, friends, who could also visit our site.
- In the Sept 2016 Website Report we gave the analytics of our site over the past year, a quick summary
- Sept/15-Aug/16 216,000 visits to our website over 813,000 individual page views. I shared these numbers with Derek Story last year and he was impressed with these numbers for a Sports Organization.
- Being in business for the last 20 I am aware of advertising costs. I would not attempt to put a price on a)
 and endorsement of a product or company over another by BC Baseball, or b) give access to those
 numbers of people or volume of traffic without talking to experts to establish fair market value for such
 postings.
- Please note, none of these people of companies that I am aware of offered to pay for or make a donation to BC Baseball for such exposure,
- In the near future, we could have a sponsorship package that involves website presence. It is, therefore my opinion that at this time, BC Baseball not give access to our website to any individual or company wanting to promote any of the above items for profit.

• Point 2

Discussion around Social Media. I had a brief discussion with John this morning about the different social Media platforms and social media management tools. Twitter, Facebook, Instagram LinkedIn, being the main ones. I would ask the board to table the discussion until the March meeting so I can be present or on the conference call. I would also like an opportunity research how we integrate the management tools such as Hootsuite with our website.

- I will say this, with respect to articles and posting on our website, and on social media, I do not feel the issue is the platform(s) that we distribute our information on. It is my opinion the issue is getting **content** to post. I believe information is posted and distributed when we get it. This was demonstrated last week at the Island Coaches Convention.
- Post were made prior to, during and after the event. But the bottom line is we need the content to post
 regardless of the platform. We know what main events are coming up. For example Coaches Conference,
 Caravan, John Main, Girls Baseball, Challenger, Tryouts, Showcase games Provincials, etc. We can
 prepare in advance, articles and releases that we are going to post and distribute leading up to, during
 and after the event.

I am in the process of creating a form that can be used to submit information for posting. Again, I believe any discussion around social media should be around **content** not platform of distribution. And again I hope the board can hold of in discussion and decision until the March board meeting.

- Users will not be allowed to post for free on our web site if they will make a profit from such ads
- If ad will benefit our players ad may be approved
- Web site needs a bit of housekeeping
