Jeremie B: Youth Hockey update

- Adding Bantams to High School STP was “genius”
- Update on Youth board issues. This is hopefully being resolved with new election this summer.
- Hockey Ops group will make development decisions and work with High School hockey coach
- Jeremie would like to keep attending meetings

Tom Develice:

- D10 cannot disband a booster club, only the State Secretary or Federal Government can do this
- Coaches cannot vote on any board
- How much a booster club wants to spend on the team is up to the booster club.
- Tom encourages Jeremie to be here at club meetings to bridge youth and high school programs.
- STP
 - *Tom did not notify Bill at CRIC in time to cancel the ice time for today. He will look at covering the cost.
 - *we will not be doing STP on Wednesday's. No need for Katie Moe skating sessions.
 - *Is there a way to cut the charges with only 2 days a week. (example: Osseo/Park Center are charging \$290 for 2 days a week)
 - * wants STP to be affordable for all families
 - *wants more advertising done for STP. (he does not want to hear that someone didn't know about STP just 2 days before it starts.)

Questions:

- Tom did not know about these because he did not get a contract. However, verbal agreements could have been made.
- Steve E says a contract has been submitted for Duluth trip.

Bank statement can be removed.
Ask Steve Moe if we can get Twitter account
- Issues with Lettermen's allowing ordering by just saying they're with CRHS hockey.
- Tom plans to attend at least 1 STP to ask kids what they would like.
- Strength Training
Can kids go to just Tuesday and Thursday?
*Kids can go to all sessions if they have paid for STP.

- Email to be sent out to all to come on Thursday and plan for STP
- Jeremie B reached out to 4 goalie coaches to see if they could help out.
- Jerry will talk to Scott Billey and discuss pay
- Motion to pay up to \$ for both on-ice coaches
- Approved
- Goalie Coach TBD
- Proposed to knock off \$100 of STP fee or knock cost down to \$325
- Need to work on numbers, this will be proposed in the next few days.

Summer Tournament already signed up. Cost is \$895

- Unknown date for tournament at Super Rink
- Nothing has been paid yet for tournament
- Tourney was not on registration
- One team only but up to 2 teams
