



New England Wildcats Hockey Club Player Contract

U8/U10, U12, U14, U16, U19 Split

This Contract Agreement is entered in to in the State of New Hampshire
Between _____ Born on _____ (PLAYER) and jointly by the Player's
parent and/or legal guardian(s) _____, residing
at _____ (PARENTS) and the New England Wildcats
Hockey Club (Organization) for the 2026-2027 hockey season, which is defined as lasting from the date
of signing of this agreement until the completion of the USA Hockey National Tournaments (The
Season). It is understood that the parties intend to be legally bound by this agreement, and that this
agreement was signed in, and is enforceable, in the State of New Hampshire. As a member of the New
England Wildcats Hockey Club, I/We agree to the following:

1. The Parent understands that if the player resigns or otherwise voluntarily terminates her participation for any reason after signing this agreement, the player is not entitled to a refund of the player fee and must pay the entire remaining balance of the player tuition before a organization's player release form will be issued. **INITIAL** _____
2. The player agrees to play youth ice hockey full-time for the New England Wildcats Hockey Club. In the event the player is rostered as an alternate on another team, she agrees to fulfill all New England Wildcats commitments prior to any alternate commitments. I.e. she will not play an "alternate" game prior to a Wildcats game on the same day. In the event of a direct conflict the player will participate with the New England Wildcats unless previously agreed to by program director and coach. **INITIAL** _____
3. The Player agrees that she will attend all of the organization's ice practices games, off-ice training, instructional sessions, and organized team meetings, except when prevented from doing so for educational or medical reasons, in which case, the player will inform her coach in advance (when reasonably possible to do so) to be absent. The organization acknowledges that such permission will be granted for all reasonable requests. The player

agrees that she will maintain her academic and educational course work at the highest level possible. **INITIAL** _____

4. The Player and parents agree to obey the laws of the State of New Hampshire and that she will maintain good citizenship and behavior at all organization events, as well as in her everyday life, recognizing that her behavior reflects this organization. **INITIAL** _____
5. The player agrees not to use vulgar or profane language, racial, ethnic, or gender related slurs towards teammates, coaches, officials, opponents, or spectators. **INITIAL** _____
6. The player agrees that alcohol, tobacco, and all legally banned substances are prohibited. **INITIAL** _____
7. The player recognizes that there is no place for violent play where the intent is to injure another player or opponent. **INITIAL** _____
8. The parent agrees to respect organization staff and volunteers. Parent agrees to conduct themselves in respectful way, and refrain from yelling, taunting, threatening, or using vulgar language about, or toward and team official, player, coach, opponent, or spectator and any organizational function. **INITIAL** _____
9. The parent agrees to be responsible for the financial commitment made in this agreement (which includes the payment of a registration fee and player fee), even in the event that the Player's organization or playing privileges are suspended and/or terminated for any reason, including but not limited to disciplinary, injury, or illness, and understand this to mean that in no case will the player fee be prorated for any portion of the season. **INITIAL** _____
10. The Parent agrees that the registration fee and tuition deposit are non-refundable. If the player declines his/her position on a team, after the date designated by the organization, the player will not be entitled to receive a refund. **INITIAL** _____
11. The parent shall be obligated to pay the organization tuition as established in the payment schedule for participation as a member of this organization, with the understanding that if a payment is delinquent, then the players playing and participation privileges with the organization and her team will be suspended until the delinquent amount is paid or an appropriate payment arrangement is made with the organization. **INITIAL** _____
12. The Parent understands that the organization may, at their sole discretion, based on past payment history, or other sound business practice, elect to require the full payment of player fees once a player is placed on a team. **INITIAL** _____
13. The player understands that she is responsible for fines or costs assessed for damage to facilities, locker rooms, etc., used in conjunction with the organization's practices, games, or other team events which are caused by the above-named player. **INITIAL** _____
14. The parent understands that any discounts will be forfeited if any payments are not made on a timely basis. **INITIAL** _____
15. The parent understands that the organization is entitled to assess a reasonable charge for any returned check or credit card charge. **INITIAL** _____
16. The player and parent agree to abide by all rules and regulations of USA Hockey, and/all active leagues the organization is participating in and any/all organization protocols, procedures, and guidelines. **INITIAL** _____
17. The organization does not guarantee or promise that it can improve the college or professional hockey potential of the player. However, the organization will provide, to the best of its ability, the best environment, coaches, and skill development, to assist the player in realizing her full hockey potential. **INITIAL** _____

account is in good standing – this includes any prior seasons balance AND any uniform balances you may owe. Payment extension requests will be considered only if the request is submitted in writing to Andrea Tarr. If approved, such extensions will allow for a new due date to be negotiated. Any player with an outstanding balance as of December 31, 2026 will be removed from the team’s roster until the player’s account is paid in FULL. Scheduled payments are accepted by Money Order, Check or credit card or Venmo. I/We have read and understand and agree to the tuition listed above.
