

ONTARIO CHAMPIONSHIPS REMINDERS



- Teams are permitted to play in multiple OC's provided they are not playing 6 days straight.
- Registration for all events opens December 13th for of age and playing up teams
- Registration deadline is January 10th, for all age divisions and the playing up registration
- Athletes can only be listed on 1 roster per event
- Stay to Play booking date are <u>online</u> however hotel preview links will be available starting in November.
- Travel rebate policy information will available later in the fall.

 (E-PIC) completed within 3 years. Can be completed online at the OVA's My Back Check Website
- September 7, 2023 Hosting Bids due
- December 1, 2023 Submit Hall of Fame Nominations for the Class of 2024
- December 10, 2023 OVA AGM
- March 24, 2024 Submit Club staff nominations for OVAtion Awards

Athletes will be required to register as members in the MRS in one of the following categories prior to participating in any on-court activities:

Activity	Required Membership Level	
Tryouts (prior to Sept 1st)	Tryout Player (Brand new members not currently in MRS)	
Tryouts (Sept 1st onwards)	Tryout Player or Recreational Player (Returning members)	
Club Practices	Recreational Player or Competitive Player*	
OVA Compositive Event	Competitive Player (6v6 Rallyball to 18U)	
OVA Competitive Event	Recreational Player (4v4 Rallyball)	

[•] Note: athletes can keep a Recreational membership role until the first competitive event of the season but must be a competitive player on the day of competition.

• Playing with an ineligible athlete or having an ineligible coach on a bench during an OVA event may forfeit your team's results.



SAFE SPORT: OSIC UPDATE

- As of June 20, 2022, Volleyball Canada and Ontario Volleyball are Program Signatories of the Office of the Sport Integrity Commissioner (OSIC).
- This means that any allegation of maltreatment or other prohibited behavior, as defined in the <u>Universal Code of</u> <u>Conduct to Prevent and Address Maltreatment in Sport</u> (UCCMS), against a UCCMS participant of Ontario Volleyball **must** be filed directly with the OSIC:
- All such complaints or reports will then be addressed according to the policies and procedures of the OSIC.
- New Attestation added to MRS Registration process





SAFE SPORT: OSIC UPDATE CONTINUED

- •In order to be fully compliant with UCCMS and insurance requirements VC now requires that all Persons-In-Authority (PIAs) be fully compliant with Safe Sport requirements before their membership status is approved.
- •Persons-in-Authority may not participate in volleyball activities until they have met their Safe Sport requirements. This means that PIAs cannot be involved in practices, camps, games, or meetings until they have completed their PIA requirements.
- •For the 2023-24 season, when an individual purchases their VC/OVA membership for a membership category requiring Person-in-Authority checks, they will be placed in a "pending" state until their PIA requirements are verified as completed. At that point their membership status will change to "Approved" and only then will they be able to engage in volleyball activities.



SAFE SPORT: CLUB LEADER ELIGIBILITY POLICY

- All individuals who are club administrators, which include all levels of club executives and club contacts, need to be OVA members, need to be listed on the OVA Club Information Form and must complete the following requirements prior to their registration as an OVA member.
 - Abide by the OVA Screening Policy
 - •Submit a Level 2 Criminal Record & Judicial Matters Check (CRJMC) or Enhanced Police Information Check (E-PIC) completed within 3 years.
 - •Complete the <u>OVA</u> Screening Disclosure Form via MRS registration
 - Complete the following training
 - •Rowan's Law requirements
 - Attest resources have been reviewed during OVA annual registration
 - Making Head Way (Free)
 - Making Ethical Decisions Online Evaluation (\$85 or free if the course was completed)
 - Coaches Association of Canada Safe Sports Training (Free)
 - Ontario Human Rights Commission Call It Out training (Free)



CLUB INFORMATION FORM

NEW

All Club Executives and Staff must be registered members of the OVA in order to be added to the Returning Club Form

- Will be searchable by name or email
- Only active members will be able to be added so Club Leader Eligibility requirements must already be completed
- Attestations must be signed by the individual completing the Returning Club Form
- Further attestations will need to be signed individually by each Club Executive



COACH ELIGIBILITY POLICY

- One main change for 2023-24 season, ALL coaches Head and Assistant must meet all requirements of the Eligibility policy
- Focus on safe and responsible coaching
- Easily accessible and available courses
- Applies to all coach members
 - 4v4 modification If a team splits in 2 rosters for a 4v4 event, there must be a registered Coach who meets the eligibility requirements on at least one of the rosters at the event.
 - o Requirements must be met before registration
- Additional requirements for VC Nationals. See VC website.



SCREENING REMINDER

- Police background checks can be completed online through the OVA's link to mybackcheck.com (valid for 3 years)
 - > This is not a mandated service to use it's a tool in place for members to easily obtain their PRC
 - > Must be an Enhanced Police Information Check (EPIC) with local police information
 - > Please send a copy to your club contact in charge of screening (downloadable PDF) for them to track for the Club's screening process/to enter on the Club form.
 - > If you already have a current PRC/VSS on file with your club, you do not need to re-do this process.



OPEN AND OBSERVABLE ENVIRONMENTS: RULE OF TWO



WHAT IS IT?

RULE OF TWO states that there will always be two screened and safety-trained adults with a participant, especially a minor athlete, when in a potentially vulnerable situation.

WHAT ARE OPEN AND OBSERVABLE **ENVIRONMENTS?**

Open and observable spaces involve making meaningful and concerted efforts to avoid situations where a person of authority: coach, official, staff member, etc., might be alone with an athlete and/or vulnerable individual.



Not closed or concealed from others



secluded locations



Others should be aware the interaction is taking place



Others can see observe or take note of the interaction

TIONS

one-to-one electronic messaging and ensure that all communications are sent to the group and/or include parents (for minors) or other certified coaches and/or staff members

CONSIDER

the gender of the participant when selecting the screened people for the closed meeting.




