Additionally, I do not have any conditions that will increase my likelihood of experiencing injuries while engaging in this activity.

Rules of League

Teams are allowed a one-hour warm-up prior to start of game.

ALL TEAMS WILL HELP SETUP AND TAKE DOWN FIELD. (See dome staff for details)

You are allowed 25 minutes in batting cage (2 batting cages).

Share warm up space equally and fairly.

No metal\plastic\rubber cleats allowed.

No food or bottle drinks allowed in dome. (See Dome staff for details)

A ball hit into dome surface is a dead ball. A ball hit into dome surface past midpoint of outfield and determined by umpire to be fair will be a homerun. A ball hit into net cable is a dead ball.

Games end at 55 minutes or play through to 115 minutes (to be determined by coaches prior to game). Umpires are allowed rest breaks if needed.

All behavior determined 'un-sportsmen like' by umpire or dome staff will not be tolerated. A first warning will be given, and any subsequent incident will result in removal from dome.
