- 2. Executive Committee Reports
 - a. Secretary Carrie Biggin
 - i. Approval of October 11th, 2020 minutes: Motion to approve the minutes by Jen B., Second: Twila H. Motion carries.
 - b. Treasurer Anne Marie Malkovich. The balances are smaller but we also have lower ice costs to date.

 - c. President Elect Eric Seidel: COVID updates have been sent out. SPYAH has been deemed an outbreak/cluster by Dane County, not advising shut down at this time. Coaches need to watch kids more closely, no exceptions.
 - d. Past President Chris LaRowe:SP Ice meeting rescheduled to this week. October & November My Hockey tourneys have been cancelled.
 - e. President Suzanne Doody will present later in agenda.
- 3. Committee Reports
 - a. Volunteer: Nothing to report. Likely re-evaluating volunteer hours in December.

- b. Fundraising: Megan Jordan reported they are moving forward with the blanket fundraiser and decals. Looking into restaurant oriented fundraisers.
- c. Communications:
 - i. Roughly same amount of posts, engagements are down; up 104 followers; Collen looking into why; up 63 followers on IG; up 5 on TW; enewsletters--43 more opening; 3 unsubscribed; team reps and board members should feel free to send pictures and updates to communications; 1-2 days advance notice helps; Colleen and Nate have a calendar going to keep on top of this.
 - ii. We only have 96 volunteer session registrations. We do need everyone registered in case we end up with volunteer opportunities.
 - iii. Also need to remind people that they DO need to register each season.
- d. Cardinal Cup: No report; asking when decision on 2021 Cardinal Cups will be made
- e. Concession Stand: Tara Freund reported that concessions opened for THFF, only had 2 customers. Considering polling the association to see if they would be comfortable with any purchasing options; will need to pull expired items soon.
- f. USA Hockey Initiatives: Looking for 2nd volunteer. THFF update: 1st session: 12 reg/9 showed; 2nd session: 8 registered/ 6 showed; PPE for all; plenty of room to social distance; both times limited to 15 registrants.
- g. ACE Directors: Jerry reported that Mites are doing good, working in pods.
- h. Equipment Committee: Luke reported that equipment is being cycled. Sign Up genius being used for trading up & out equipment and going very well.
- i. Jerseys: Maggie had nothing to report.
- j. Registrar: Nothing to report.
- k. Spiritwear: Morgan reported that the upcoming store will open next week. Items purchased in this session will arrive in time for Christmas.
- I. Ice Scheduler: No report.
- m. Region 4 Meeting: Middleton will not be playing games this season, only practicing. Midgets can play JV/Varsity, most associations doing similar to Sun Prairie; some rinks closed, some open; WAHA debating if State should occur.

- e. PeeWee level teams discussion: Julie presented options, which include pulling up a Squirt level player, only 1 is interested at this time. PWC2 goalie issue is relatively solved. Double rostering is no longer an option on the table this year with COVID. Other options include combining the 2 C level teams, which would equal 22 players, keeping 2 C teams as is. C1 prefers to keep 2 separate teams. C2 predominant feeling is 9 players and 1 goalie is too little and will result in a poor experience. Discussion had regarding behavioral issues, etc...

- g. Mite Team Mgrs. Non-concession hours: motion made by Brandon to grant all Mite team managers all non-concession hours (5) after completion of Safesport and certification. Second by Carrie B. Motion carries, all approve.
