Rotary Cup Tournament-Final Planning

Subject: The schedule will be out before Sun July 4. Kimberly is working on it – currently we have 63 teams, the most we have ever had. We are needing to start the games earlier on Friday, maybe around 1pm. Courtney will Eblast about DIBS again as we don't have volunteers for anything yet. She will also ask team Managers to ask parents to sign up, there are 2 pages on the website with spots.

Henry will call about more garbage cans both at the complex and DLK02, also more port-a-potty's at both locations. He will have a crew on Thursday night to paint the fields and double check the nets one more time. We will need fields #3, #4 and #6 double painted as Kimberly will need both field sizes thru the tournament.

Courtney confirmed with the Fargo company on the golf carts and the delivery of the white tent all for Thursday night.

Kimberly will pickup all of the concessions beverages and food from Central Market on Thursday too. We will need 800 jumbo freezies, Kyle is freezing them at Central Market for us.

Central Market is also letting us use their 2 large white coolers to keep Ref waters and other beverages cold – the fridge in the back can't keep up if it's packed too much.

Henry will rope off 4-5 parking spots on top of the hill by the concessions for Handicapped Parking and "do not park" spots. This is so we can get in and out with Refs for DLK02 and to drop off more food for concessions. He will also cone off the section by the tree line for staff to park.

Joe Braun is bringing up his camper to use for a headquarters and Ref cooling room.

Friday we need to start set up by 9am. Ben and Kimberly will set out flags and set up registration/Ref tables/score sheets/concessions/grill. Henry will set up DLK02.

Ben and Joy will run the Registration table all day Friday, ends around 8pm. All teams should be registered on Friday, so not needed Sat morning on DIBS. Saturday need to start at 6:30am- Jake and Kimberly will set up fields/Ref table/Score Sheets/Concessions/Grill.
