This information will be posted to the Boosters website so that our members have a clear picture of where money is spent and why we run tournaments/require volunteer deposits.

Coaches Handbook Updated:

DeeDee updated the coaches' handbook with additional information, last time the handbook was updated was 2011/2012 season. The updated document will be posted to the Boosters web site.

Volunteer/Uniform Deposit:

It was agreed that additional information should be added to the registration process to make it EVEN CLEARER what this requirement is for all players/families. A short document explaining key items will also be given to coaches to distribute to players/families as part of the season start up. This information will be reviewed/approved at the April meeting.

Tournament Improvement:

Ray suggested we look into getting a pepsi/coke cooler that we could use for tournaments vs the using camping coolers and ice. Would reduce the water/mess created.

Summer Opportunities:
