### **5. COMMITTEE REPORTS**

- a. **Volunteer Committee**: Requested to be part of eval week/check-in to talk DIBS, commitments, etc. Board agreed; someone needs to remind them when/where to be.
- b. **Communications Committee**: Nothing to report. Capitals reached out for kid pics for youth hockey promotion
- c. **Cardinal Cup Committee**: Looking for replacement for Kory S. Casey M. said no; Eric S. knows someone else and will have answer for July meeting.
- d. **Concession Stand Committee**: No update. 4 people are staying; (1 person leaving but Tara F. thinks they will be fine with 4).
- e. **USA Hockey Initiatives**: Need to find out if Marissa & Erin are staying. Suzanne will still help with coaching
- f. **ACE Director(s)**: Dunt believes he found ACE replacements and will motion/vote on in July.
  - Tara motion for non-travel ACE to be L2 by December 31 of that season; Jenn 2nd motion passed
- g. **Equipment Managers**: 1 person leaving; committee asked for 2 to replace. Committee feels a parent with a young player would be good for longevity. Mark Kuehn, Dave Schroeder staying and should be part of discussion for creative alternatives. MM/MT have fewer hours, can have that parent be there less often but start learning for smooth transition.
- h. **Fundraising Committee**: Purse bingo planned for this summer. Trivia night geared towards dads.
- i. Jersey Coordinator: MM do new logo; Maggie getting samples; might coordinate with HS. MT consider getting them reversible jerseys. MD stay with old jerseys NO changing of jersey numbers; administrative nightmare. Registration opens July 15; Maggie will find camps for jersey and warm-up try-ons. No ordering of extra jerseys; all extras came back, no changes to socks, closing registration on September 1<sup>st</sup>, will get orders in within 2 weeks. Overall the order will be way smaller

this year. Need to get to Maggie: color of MM jerseys and decision on purchasing MT jerseys.

- j. **Spirit Wear**: No update. Is Morgan still interested?
- k. Registrar: Nate nominated/approved above. He will contact Brenda for training.
- I. **Region 4 Meeting**: Aug 5-6, 2022 in Stevens Point. President's meeting on Friday, Coaches Director meeting. SPYHA budgeted for 2 people to attend. Officiating fees going up by 5%, admin fees not going up.

## **6.** LEVEL REP REPORTS

- a. Mini-Mite: absent/no report.
- b. Mite: no report
- c. **Squirt**: Some summer opportunities for kids. Chad will work with Jenn on transition.
- d. **PeeWee**: 4 teams. A lot of goalies, Getting interest for an all-girls' team.
- e. **Bantam**: Twila H. absent. Reviewing BA numbers: confirmed 28 players; 1<sup>st</sup> year BA players (removes girls going to Mavericks), 5 returning; 34 kids; 17 players on each team, we are close to 3 teams. Beaver Dam looking to co-op 6 players (4 Bantams) if we add BD, now at 40, definitely 3 teams. If co-op with BD, we will get practice and game ice in return. Coach Giesegh has 14 freshmen signed up, 4 are not eligible for BA, so down to 10, 5 definite; 5 are flex, still no cuts; whoever shows up gets put on a team. Can utilize MD ice if we go to 3 BA teams. Yes, MD does not need to practice alone; work with coaches to see who shares.
- f. **Midget**: Aysha D. absent. With no HS cuts, may be hurting for numbers, take it day by day as we move forward. If we have enough kids, push season align with HS season or be a fall/spring-before/after team. No cuts now but when we have 1 varsity team at each HS, there will be cuts and those kids cut will NEED a place to play.
