- 1. <u>Executive Committee Elections (Vote)</u> Elizabeth reviewed the below positions and candidates. The candidates made brief statements, then ballots were completed and submitted. Final tallies of the ballots are on the UWHL's google drive.
 - a. Open Executive Committee positions
 - i. Treasurer
 - (1) Nancy McGuire was nominated for this position and was elected.
 - ii. One Conference Liaison
 - (1) Chrissy Kelly and Sally Tarabah were nominated for this position.
 - (2) Chrissy Kelly was elected.

2. Annual Reports (2018-2019 season)

- a. Karen reviewed the 2018 Annual League Meeting minutes. A motion to approve the meeting minutes was made and seconded. The minutes were voted into the league record.
- b. The 2018-2019 Annual Report was reviewed by the Executive Committee. A motion to approve the annual report was made and seconded. The annual report was voted into the league record.
 - i. Mo Sharon reviewed the Treasurer's report which was provided as a hand-out. The topic of the UWHL Classic prompted discussion. In 2018-2019 more teams than usual opted for the Classic buy-out. Ideas to boost participation were raised. The discussion continued when the General Items of Interest and Season Notes were reviewed.
 - ii. Karen Shull-Archer reviewed the Secretary's report.
 - iii. Lauren Solski reviewed the Playoff report.
 - v. Elizabeth Lundin reviewed the General Items of Interest and Season Notes.

3. 2019-2020 Planning

- a. UWHL Winter Classic
 - i. The 2019-2020 UWHL Winter Classic will be held at the PPL Center on Girl Scout Night, as in the past. It is too cost prohibitive to move the event to a Flyers game due to Flyers ticket cost. If the trend of increased buy-outs from teams continues, alternatives will be pursued. Team Reps are encouraged to emphasize to their teams that this is the main fundraising event for the UWHL and is a means to promote the league. The Team Reps expressed the following concerns regarding the current venue. ACTION: Elizabeth took an action to issue a survey with options for the UWHL Classic. The survey should be issued before the start of the season.
 - (1) The venue is too far. Teams struggle to find people to make the drive. Players like a break in the schedule.
 - (2) The date is too close to the holidays. Try a different date.
 - (3) Condense to one ice slot, then teams can only send 1 player but still sell tickets.
 - (4) Hold a skills competition in place of or in addition to a scrimmage.

- (5) Hold a party at a rink without involving Phantoms.
- b. League Code of Conduct: Elizabeth stressed the League Code of Conduct. For the 2019-2020 season Referees will be instructed to ensure sportsmanship is prevalent.
- c. Changes to Game Schedules: Elizabeth discussed the process for game reschedules and cancellations. Once the league schedule is posted, teams need to work out changes amongst themselves.
- d. New Teams for 2019-2020: The Patriots will enter a team in the White Division. The Senators team has folded. It is expected most Senators players will move to the Patriots.

4. Action Items and PPG Proposals

- a. Mo Sharon reviewed the 2019-2020 Budget. The below fees were proposed, seconded, and approved.
 - i. Team Fee \$200
 - ii. Playoff Fee \$300
- b. Maddie Weeks proposed an increase in minimum referee pay to \$60 per referee per game. After a discussion, the proposal was increased to \$65 per referee per game. The \$65 proposal was seconded and voted in.
 - Fees have been stagnant and are no longer competitive with boys leagues. The proposal brings the UWHL more in line with comparable senior leagues.
 - ii. This is a league mandated minimum. Teams are responsible to schedule and pay refs.
 - iii. ACTION: Karen has action to update the PPG to reflect the minimum fee for referees is \$65 per game per referee.
- c. Elizabeth reviewed proposed changes to the PPG. ACTION: Karen has action to update the PPG with the approved items discussed below.
- i. Section 4.4 Request for Player Review: The proposed language will codify the creation of a Roster Committee prior to the beginning of the season to handle in-season Player Review requests, if no committee is formed, Player Review requests will be handled at the discretion of the Executive Committee. The change is needed due to the difficulty in forming a committee mid-season.
 - (1) The use of LiveBarn was considered, but the video is not good enough to make out players numbers.
 - (2) Elizabeth is asking for 5 volunteers for Roster Review Committee. Coaches can participate. Can't review within your division.
 - (3) Challenge is reviewing a player against an equivalent team.
 - (4) The proposed language was voted and approved

- ii. Section 5.2 Goalie Rostering and Substitution Policy. The proposed language will:
 - (1) Replace language referencing notification going to the Vice President with notification going to the Secretary
 - (2) Clarify that if a proper substitute goalie cannot be found, a skater already rostered on the team may dress as a goalie, provided they are not already rostered as a goalie in a higher division
 - (3) The proposed language was voted and approved.
- iii. Section 6.8 Game Schedule Changes, Cancellations, or Forfeitures. The proposed language clarifies that all players of the non-offending team in a forfeit will be credited with a game played provided they were rostered on the team at the time of the forfeit. The proposed language was voted and approved.
- iv. Institute new PPG rule prohibiting League games from being scheduled to start after 9pm
 - (1) Proposal to limit game start time to 9 pm on Saturdays and 7 pm on Sundays. Provide this as guidance, not a hard and fast rule since the rinks may not be able to comply.
 - (2) The proposed new rule was voted and approved.

5. League Structure

- a. Elizabeth proposed the below structure for the 2019-2020 season.
 - i. The new Division was named Silver.
 - ii. There was discussion concerning the Blue teams playing the same 4 teams and 2 are in North Jersey. There was a request to consider promoting the winner of the new Silver Division to Blue next season, however this should not be an automatic league rule since rosters may change season to season.
 - iii. The proposed structure was voted and approved.

 - (2) Teams need to provide 8 home ice slots
- c. The new Silver Division teams and season structure will be as follows.

- ii. 16 game season
 - (1) Each team plays each other 4 times (2 home/2 away)
- iii. Rostering process
 - (1) Teams roster from last season get grandfathered.
 - (2) New players to Silver Teams will go through Player Review Process.
- iv. Need to know ASAP if teams want to move into new Silver Division.
- d. The White Division teams and season structure will be as follows. Initially teams were assigned to a North and South sub-division based on home rink location. There was concern among the teams the geographic division resulted in lob-sided competition (i.e. one team would dominate a sub-division). The sub-divisions were eliminated.

 - (2) Teams need to provide 8 home ice slots plus 1 extra

- ii. 15 game season
 - (1) Each team plays the other teams 3 times (1 home/1 away with 3rd game assigned based on ice slots)
 - (2) Teams need to provide 8 home ice slots plus 1 extra

6. Playoffs

- a. The proposed structure for playoffs was discussed and approved.
 - i. Blue: all 4 teams will qualify for playoffs.
 - ii. Silver (new): top 4 teams will qualify for playoffs. The 5th place team does not qualify.
 - iii. White: Two 4-team divisions, seeded on regular season standings. 9th-11th place do not qualify.
 - (1) There was discussion to only have one play-off division for the top 6 teams. The 1st and 2nd place teams will get a bye, while the 3rd to 6th place teams will have a play-in game. ACTION: Executive Committee re-evaluate the White Division play-off structure towards the end of the season and make changes, if needed. A 6-team playoff bracket uses less slots then an 8-team bracket.
 - iv. Red: top 4 teams, 5th-6th place do not qualify
