Old Business

Grant Writing/Fundraising

- Pat Culp got a phone call from Nancy Campbell who stated JJ Pinter from Floyd does a lot of this.
 - He is recommending he help the ISWA and would like to sit down with the executive board and the board to set up what we are looking for.
 - o He says a huge fundraiser might be a good way to get started.

- o He doesn't recommend setting up grants as a percentage because of IRS views.
- He thinks it could be set up as a bonus and once set up, he would like an attorney to look at it.
- Pat Culp would like to set up a time for the exec board to meet. She said he is very knowledgeable.

Elementary Duals

- Pat Culp reported that they just had a tournament committee meeting.
- Ft Wayne coliseum was set up as back-up because Franklin was possibly not being able to host.
- Allen County and Johnson County are under red for COVID.
- Jimmy Tonte was able to get an appointment with the Gathering Place in Greenwood.
- He and Pat Culp went there and toured.
 - They were not going to allow any additional wrestling events due to experience with the last couple of events they hosted.
- Pat Culp is working with Johnson County health department to obtain approval.
- She is looking at Saturday to see if they have availability to wrestle Saturday at 2pm.
- Trying to determine where to have weigh-ins.
- Maybe hold at an offsite location.
- We have to keep people in the 25 people bunch. Have to be masked up.
- Talked about not allowing outside food to be brought in.
- Each child can only bring 1 spectator.
- Contact tracing will occur with sign-ins. May sell tickets in advance.
- As of now it is a go at the Gathering Place in Greenwood.

Upcoming state tournaments

- Middle school state will be at the Gathering Place in Greenwood.
- Working on staggering weight classes.
- Will have to do 3-4 sessions throughout the day.
- Individual state. Will not be doing qualifying.

Middle School Duals

- Will also be at the Gathering Place. They weren't available for Folkstyle state.
- They have penciled us in for Freestyle/Greco state in case Avon cannot host. Josh Curry asked if we could prepare the checklist and get the process started for their health department. Directed him to the website for the checklist and the board of health information to be provided.
- Pat Culp said the place is large enough but for social distancing we ill use smaller mats and more sessions.
