Volunteer Opportunities at Corky's Early Bird Tournament

Parks Department provides: Garbage pickers, buckets, bags to reline trash barrels.

Volunteers: Check-in at tournament headquarters, turn in completed waiver, pick-up supplies.

If under 18, a parent or guardian must sign the waiver.

(1) Pick entire area continuously at fields, parking lots, sidewalks, pavilion and grounds. (2) Empty trash barrels, add new liner (put band back on barrel). (3) Put full bags in garbage dumpster (not recycling) or, if no dumpster, behind portable toilet. (4) Return items to tourney headquarters. Communicate any trouble areas with next crew. Note: Out-diamonds are Owatonna Middle School, Brown, Manthey & Lincoln

Per city insurance coverage and labor guidelines, volunteers may only be used for the duties outlined above.

VOLUNTARY WAIVER OF LIABILITY AGREEMENT

I wish to participate in tournament clean-up (the "Activity"). I state and affirm that:

- 1. My participation is voluntary. No one is forcing me to participate.
- 2. I acknowledge the Activity is <u>NOT</u> an <u>ESSENTIAL</u> service provided by the City.
- 3. I understand and acknowledge the Activity I am about to voluntarily engage in as a participant has certain risks, including but not limited to, injuries incident to yard work, including but not limited to hand injuries, head injuries, slip and fall injuries, muscle strain or sprains. I understand these risks known or unknown, anticipated or unanticipated may result in injury, death, illness, disease or damage to myself or my property, or to other persons and their property.
- 4. In consideration of being allowed to participate in this Activity, I hereby personally assume all risks in connection with this Activity and I hereby agree to hold the City, its officials, employees, agents and contractors harmless and I waive any right to make claims or bring lawsuits against the City or anyone working on behalf of the City for any injuries or damages related to the alleged negligence of the City.
- 5. This waiver does not apply to any injuries or damages that are the result of any <u>willful</u>, <u>wanton</u>, or <u>intentional</u> misconduct by the City or anyone acting on behalf of the City.
- 6. I understand that entering into and signing this agreement affects my legal rights and result in my giving up or waiving certain legal rights, and I accept this and sign this agreement of my own free will.
- 7. The terms of this agreement shall bind the members of my family, if I am alive, and my heirs, assigns and personal representatives if I am deceased.
- My signature indicates I have read and understand this entire document and that I have received a copy of this document. I understand it cannot be changed by oral representations but only in writing. I agree to be bound by its terms.
