- I. Upcoming election for four committee positions are as follows. The election will be run by RACC, Marian Dewane, in the next couple of weeks. All those voted in will take office on August 1st:
 1. Southern Compulsory Rep has three people who have been nominated – Khumbulani Moyo, Joy Rutherford, and Alyssa Lytle
 2. Optional Rep – only one candidate nominated – Denise Nontavarnit; SACC will cast the one vote needed and Denise will be named the Optional rep
 3. Northern Compulsory Rep – only one candidate nominated – Cassandra Rowell; SACC will cast the one vote needed and Cassandra will be named the Northern Compulsory Rep.
 4. Xcel Rep – only one candidate nominated – Heidi Fogarty – SACC will cast the one vote needed and Heidi will continue as the Xcel Rep.

- Meg noted an upcoming change from the national office requiring that all USA Gymnastics committees have 30% of their members be athlete members in the near future. Our current understanding is that these members will need to have competed within 10 years of taking office. The committee will begin reviewing all committee positions at the next committee meeting in anticipation of this change.
