Coaches and Referees: Todd Valnes is working on getting coaches together for the 2007-2008 season. Steve Delehanty expressed desire to divide squirts up by ability. It was confirmed that at the joint meeting that we would have two squirt B teams.

Tournaments: 4 teams have turned in forms for tournaments and 2 have paid. One Bantam B, two Peewee B and a Squirt C team have registered.

Concessions: We will have the concession stand open for the auction being held at LCC on August 18th. We will serve hotdogs.

Manager, Lee Community Center report: Ron has sent out the open skate schedule. The condenser is here. The county is coming August 16th to remove the old condenser. Water heaters are in progress. A bid was received from Nathan Petersen at \$7,851.00 for two 98 gallon, 185,000 BTU water heaters. Mats in locker room 4 need to be replaced. Rob Jergenson will get belting to use for mats. There are four rentals in September and October that will bring in \$1500.00. Ron would like to use \$800.00 to purchase new tables.

Jim moved to purchase up to \$1000.00 in materials to build a spray boom for painting ice and to purchase \$800.00 in tables. Ann seconded. Motion carried.

There has been no response for bids on a zamboni.

Ron expressed the need for two work nights before the ice goes on.

Amy Christians moved to adjourn. Ann Vipond seconded. Motion carried.
