Release and Waiver Liability, Assumption of Risk, and Indemnity and Parental Consent Agreement in Consideration of being permitted to participate in any way in Champions Sports Center LLC. programs and training sessions (collectively "activities") (which I acknowledge I or my minor athlete would not be allowed to participate in but for signing this agreement) I, for myself and for my personal representatives, assigns, heirs, and next of kin:

- ACKNOWLEDGE, agree and represent that I understand the nature of activities and that I (or my minor athlete) is qualified, in good health and in proper physical condition to participate in such activities. I further agree that if at any time I believe conditions to be unsafe, I will immediately discontinue (or my minor) from further participation. I assume full legal and financial responsibility for their participation in the activities.

I FULLY UNDERSTAND THAT; (a) THE ACTIVITIES INVOLVE RISK AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH, (collectively "Risks"); (b) these "Risks" may be caused by my own (or minor's action) actions or inactions, the actions or inaction of other participating in the activities, conditions in which the activities take place or actions or inactions of the Releases named below; (c) there may be OTHER RISK and SOCIAL and ECONOMIC LOSSES known or unknown to me or not readily foreseeable at this time; I FULLY ACCEPT and ASSUME ALL SUCH RISK AND RESPONSIBILITY FOR LOSSES, COSTS AND DAMAGES I or the minor incur as a result of my participation or that of the minor in the activities.

HEREBY RELEASE, DISCHARGE, and COVENANT NOT TO SUE CHAMPIONS SPORTS CENTER LLC. or any owner, representatives, administrators, directors, agents, members, volunteers, and employees or other participants, any sponsors, advertisers, and if applicable, any owners and lessors of premises on which activities take place. (each considered one of the "Releases" herein) FROM ALL INJURIES, LIABILITIES, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY OR MY MINOR'S ACCOUNT INCURRED IN CONNECTION WITH THE ACTIVITIES, INCLUDING NEGLIGENT RESCUE OPERATIONS, and I FURTHER AGREE that if, despite this agreement I, or anyone on my behalf, make a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may occur as a result of such claim.

I grant full permission to the Releases with no obligation to compensate me to use my and/or participants child's name, voice, statements, images, likeness, and/or actions, in addition to any photographs, videotapes, motion pictures, recording, and/or other record of my and/or participant's child's performance (s) in the activities in perpetuity worldwide in any manner in any such media, whether now known or hereafter devised (the "Materials), and represent that I have the right to grant such permission.
- 5. ACKNOWLEDGE THERE ARE NO REFUNDS FOR ACTIVITIES. Funds may be deferred to future activities provided arrangements have been made by participants and Champions Sports Center.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without inducement or assurance of any nature and intent to be complete and unconditional release of liability to the greatest extent allowed by law and

agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.

MINOR RELEASE: And I, the minor's parent or legal guardian, understand the nature of the activities and the minor's experience and capabilities and believe the minor to be qualified, in good health, and in proper physical condition to participate in such activities. I hereby release, discharge, covenant not to sue, and agree to indemnify and save and hold harmless each of the releases from liability claims, demands, losses, injuries, or damages on the minor's account arising from or relating to the activities, including those caused or alleged to be caused or alleged to be caused in whole or in part by the negligence of the "releases" or otherwise, including negligent rescue operations and furthermore agree that if, despite this release, I, the minor or anyone on the minor's behalf makes a claim against any of the releases named above, I will indemnify, save, and hold harmless each of the releases from any litigation expenses, attorney fees, loss of liability, damage, or cost any may incur as a result of any such claim.
