

## 2026 AZ NCQ Girls National Division Qualifier Entry

This entry form and payment of \$500.00/team is due in the Arizona Region office no later than 5 pm on Friday, Feb 27, 2026 (for 18s teams), Wednesday, Mar 6, 2026 (for 11-14s teams), and Mar 27, 2026 (for 15-17s). **Late entries will not be accepted.**

**The Club Director of this team must initial each section to indicate they have read and understand the info in this box. Clubs with a balance due to the Region will not be allowed to enter teams in this tournament.**

Teams entering the AZ NCQ National Division Qualifier (AZ NCQ) must be committed to attending the Girls Junior National Championships (GJNC) in each of the 3 levels of bids offered at the AZ NCQ. Teams that are not committed to attending the GJNC in ALL the divisions offered should not enter this tournament. If a team earns a bid at the AZ NCQ and then pulls out of the GJNC they will forfeit the GJNC entry fee (\$1000) to USA Volleyball (if it is past the entry deadline) or the Arizona Region (if the deadline has not passed) and will be subject to sanctions imposed by USA Volleyball and/or the Arizona Region. Teams may only play in the AZ NCQ National Division Qualifier with players that will be attending the GJNC tournament with this team. Sanctions may be imposed on the player(s), the coaches, the team and/or the club by USAV and/or the AZ Region if players drop from this team leaving it unable to attend or reducing the competitive level of the team after qualifying. Teams that forfeit matches or disqualify themselves in the AZ NCQ to avoid finishing in a qualifying or alternate position or teams that turn back a bid earned at the AZ NCQ are subject to sanction by the Arizona Region. The sanctions for all of the above may be financial and/or participatory and will carry over to club for the next season, if applicable.

I understand that teams may be eliminated from further play on Day 1 of the event. There is only a 2-match guarantee.

\$100 will be refunded to all teams participating in the AZ NCQ National Division at the end of the season, if they complete the tournament as far as their team qualifies to participate, do not withdraw from the event after the entry deadline, do not forfeit matches to avoid qualification or elimination and do not turn back a bid earned at the AZ NCQ.

The team that places first in each age division will receive the bid to the National Division of the Girls JNC. The team that places second in each age division will receive the bid to the American Division of the GJNC. The team that finishes third will receive the bid to the Freedom Division of the GJNC. The teams that finish fourth through sixth are designated as alternates and are required to remain committed to attend the GJNC until ALL the reallocation and At-Large bids have been filled and no Arizona teams may advance further. Any team that finishes in an alternate position in the AZ NCQ, does not hold any bid, and passes on a bid that comes to the Region will be sanctioned by the Region. The sanction may be financial and/or participatory in nature and will carry over to the club for the next season, if applicable.

All Qualifying Teams: The 2026 Junior National Championships Entry must be completed in AES and the Entry Form and Fee submitted to USA Volleyball **within 10 days of qualification.** All Alternate Teams must enter AES in the Freedom Div within 10 days of qualification. USAV will change the division level in AES if the team ultimately receives a different level bid.

NO player from another club may be added to the roster of a qualified team to attend the GJNC - even with a release.

A max of 2 players from one qualified team within the same club may be added to a qualified roster to attend G18s JNC.

A player from a team that has qualified with one club is NOT ELIGIBLE to be released to another club - PERIOD.
