PARENT | PLAYER REGULATION HANDBOOK

Registration Handbook needs to be read, initial, sign and notarized to participate. Any change in Player's Information Form needs to be notify the club director via email for update. No AAU or USAV release will be award to any player in the middle of a competitive season. We reserve the right of admission. Parent, players, and families need to always follow all rules and regulations for our program no exceptions.

PLAYERS MEMBERSHIP USAV & AAU

Memberships are mandatory for all players. AAU and USAV Medical Release Forms need to be complete and turn in first week of registration. Memberships are good for one year only and expired every September 1st of each year regardless of when it is purchase. COMMUNICATION To keep all players, parents, and coaches well informed. Please help us by checking your emails frequently and our club website, torerosvolley.com

Office Hours for calls and phone communication are Monday to Thursday 3:30 pm - 5:30 pm. In person at all practices however an appointment needs to be requested first. For our program to be able to maintain affordable fees, controlling operation cost is one of our strategies to have all paperwork manage via email. We welcome phone calls, text, emails, and personal communication during office hours.

COMPETITIVE TOURNAMENT SEASON

The objective of participating in tournaments and leagues is to give the players an opportunity to test and improve their volleyball skills in a structured, competitive environment. Playing time at tournaments/leagues is at the discretion of only the coach, who will make his decision based on the level of competition, the ability of the athlete, the player's practice attendance, and the positional needs of the team and the importance of the match. Playing time will not be discussed at any time. Please help us teach your children that the best way to increase court time is to work harder in practice, hustle, be enthusiastic and respectful always. Often, players who find themselves in this situation sulk, brood, and begin to exhibit a bad attitude and bad behavior will not under any circumstances will be reward or tolerated. If you find your daughter or son in this position, please talk to your coach before it becomes a big problem. It is important that players and parents acknowledge that on every team, some players are more skilled than others. Where players are close in skill level, a good attitude and work ethic can swing things to that player's favor. Each player is bound to the Club for the entire seasonal year for competitive teams and full year registrations, which runs from August 1st of 2022 to through July 31st of the following year, 2023. Ensure you plan your family agenda with this in mind as each player will be held accountable.







PRACTICE & TOURNAMENT ATTENDANCE

Tardiness and absences from practices are subject to physical activity as discipline assigned by coaches to players. Coach and club director will take disciplinary action in consideration. Many coaches will excuse players if prior arrangements and notification are made. A pattern of missed practices and tournaments and a pattern of tardiness to practices and tournaments may result in reduced playing time at tournaments and other disciplinary actions. Parents and players are responsible of notifying the coaching staff if they are going to be absence or tardy to any practice or tournament. Parents, please help teach your children the importance of commitment and explain why the team takes priority over any individual.

Practices and Tournaments dates and hours schedule are always subject to change.

COMPETITIVE SEASON UNIFORM

Competitive uniforms will be purchase at the beginning of each season. Uniforms fees will vary as per specific season. Complete uniform will be worn during competitive events. Players always need to wear club gear while at any tournament or club event. For safety reasons, jewelry is not allowed to be wear during training, practice, or competition. Practice T-Shirt and/or hoodie needs to be purchase and wear always while at practice.

CONFLICTS AND GRIEVANCES 24 HOURS GRACE PERIOD POLICY

Unfortunately, differences of opinions and conflicts do arise. Often, they are a simple case of misunderstanding, but occasionally problems that are more serious present themselves. Questions on policy, coaching philosophy or misunderstandings need to be address through the proper channels. A coach should never be confronted immediately before or after a game or practice, or in the presence any players or other parents. A 24-hour grace period will be implemented before approaching and addressing any subject with the coach or club director. If you feel you need to speak with the coach please follow procedure, contact club director first to discussed and set up coaches meeting if necessary. No text or email if there is any situation a meeting needs to be requested. Problems should be handled privately and respectfully. Always remain respectful, even in disagreement.

If a player or parent needs to be, expel from club participation because of unacceptable behavior, financial commitment will still need to be taken care of immediately. No AAU or USAV release will be award due to unacceptable behavior expulsion. All decisions will be made in the best interest of our volleyball programs and the team.







FEE / PAYMENT SCHEDULE 2022/2023

Summer, Fall, Winter and Spring Fess will vary. Camps, Private Lessons, Skills Camps Fees will vary. Competitive season payment schedule will be given to parents every season. Financial contract needs to be sign and notarized. Payments are due the 1st of every month or first scheduled practice of each month as determine in Financial Agreement. A mandatory \$50.00 late payment fee will immediately apply if payment is not received the day payments are scheduled, no exceptions.

Payment schedule is intended to ease any financial strain associated with club volleyball fees. We provide installments as a courtesy for parents. The Financial Agreement terms are a confidentiality agreement between both parties involved and are not to be discuss with outside parties. To ensure and honor these financial considerations player must commit and attend all training and tournaments schedule for the season. After completing and signing Financial Agreement and Registration Forms, parent will be responsible for their player's fees even if player decides not to complete the season. There is no exception to the rules, if a player commits and accepts a position as part of a team, financial commitment will be honor as well as duties, obligations, and commitments.

We understand that unfortunate financial situations can occur to anyone. If any of our parents have a situation where they are unable to make their payments on time, please make an appointment with our club director to ensure we can attend to find a solution around the player's best interest. Not always, we will be able to come to a payment arrangement, but we promise to make a strong effort to maintain our players active in the program. If a player falls behind with payment, they may be restricted from participating until fees are brought up to date.

Once accepting a spot/place in a competitive team, each player is financially bound to the Club for the entire seasonal year for competitive teams and full year registrations, which runs from August 1st of 2022 to through July 31st of the following year, 2023.

Under no circumstances, payment will reimburse. Return Checks will have a \$100.00 surcharge. After first return check is process, subsequent payments will only be accepted in cash method.







EXPECTATIONS OF STANDARDS BEHAVIOR

The following standards of behavior apply to all club players, parents, guardians, family friends, and spectators.

- Use of profanity in the presence of team members, at practices, tournaments of club functions are prohibited.
- Any parent or player can be dismissed and taken of the team and program at any given moment if Toreros Volleyball Academy Regulations are not follow as required. This decision is only made by the program directors and once made will not be discussed or retract.
- Negative propaganda, participation in negative or hurtful gossip and slandering of others is prohibit. Positive reinforcement and enthuse are encouraged
- Jeering the opposition, officials, opponent players or opponent parents is prohibited.
- Do not distract your child's attention during practice, matches or coaching instruction.
- Players in training cannot take care of unattended siblings while in practice.
- When training sessions are complete, players, must immediately leave premises.
- Players, parents, and spectators need to pick up any personal belongings and trash before leaving training facilities and tournaments.
- Sportsmanship will be demonstrated always regardless of practice, match, and tournament outcomes.
- An adult in charge, parent or guardian must accompany each player at tournaments.
- Observation of facility rules and policies will be respected and adhered to at all venues and establishments that we participate in.
- Any damages caused will be the responsibility of the member's parent or guardian.
- No member of a team will be dismissed from practice, tournament until all team commitments are fulfilled and completed at the discretion of the coach or club officials.
- There are NO Chaperones or Representative Parents on Toreros rosters. We welcome parents respectful support at every event.
- Failure to abide by these standards of behavior or with the player code of conduct may result in disciplinary action at the discretion of the Club Director and Administrator. Disciplinary action can include, but is not limited to, verbal and written warnings, suspensions from club participation and expulsion from the club.

RELEASE POLICY

If you are offered a position on a team with Toreros Volleyball Academy, for the 2022/2023 season and player accepts the position, player is committed to Toreros Volleyball Academy for the entire season. A player commits to a team and completes registration with Toreros Volleyball Academy, the player is considered registered to the Club. Each player is bound to the Club for the entire seasonal year for competitive teams and full year registrations, which runs from August 1st of 2022 to through July 31st of the following year, 2023.

Accepted position is defined as one or more of the following: completing, signing, and notarizing Toreros Volleyball Academy Parent/Player Handbook Registration Forms and Club Season Agreement, completing AAU & USAV club memberships selecting Toreros Volleyball Academy as club, attending training sessions, participating in tournaments representing Toreros Volleyball Academy. Toreros Volleyball Academy will not consider a request for a release from the program during the volleyball year until that player has paid his/her entire financial obligations to the Club for the year. If approved, all fees for the entire seasonal year must be paid in full before the release can be authorized. This will include a reasonable estimate for coach travel expenses, any other fees that might be due after the player has transferred from the team as well as a \$100 club-processing fee. Players receiving financial assistance will not be released during the seasonal year unless they pay the full expenses associated with the year, including any portion of granted assistance. Each family is obligated to the full financial commitment.

At no time, a player will be release from Toreros Volleyball Academy if the integrity of his/her team is affected for the volleyball year.

At no time, a player will be release from Toreros Volleyball Academy or participate with another volleyball club without a written consent of release from Toreros Volleyball Academy's Club Director.

PAYMENT & REFUND POLICY

I understand that I am responsible for the entire financial fee of current season 2022/2023. Fees are due in accordance with the provided payment schedule. Once the parent accepts a position for his athlete on any capacity and parent player registration handbook package is sign and notarize, financial responsibilities will take place. Past due payments over 30 days or more will be refer to a collection agency and parents will be responsible to pay all collection fees. If on a payment plan contract or agreement and 30 days have passed, we will be entitled to receive the entire financial commitment balance at the specified due dates. Club Deposit, Registration Fees, Clinics Fees, Camp Fees, Private Lessons Fees, Team Placement Fees, Mini League Fees, Intramural Fees are nonrefundable under any circumstances no exceptions. If a player decides to abandon his commitments before completing his season responsibilities, parents will still be responsible for the remaining of the balance. NO REFUNDS will be granted under no circumstances.
