This entry form and payment of \$100.00/team is due in the Arizona Region office no later than 5 pm on Wed, Dec 3, 2025. The bids offered are in the 16 (2) and 18 (2) American Divisions only. **Late entries will not be accepted.**

The Club Director of this team must initial the boxes below to indicate they have read and understand the info in this box. Clubs with a balance due to the Region will not be allowed to enter teams in this tournament.

☐ **Commitment:** Teams entering the Arizona Region Boys Qualifier must be committed to attending the Boys Junior National Championships (BJNC) in the American Division or higher. Teams that are not committed to attending the BJNC in the American Division should not enter this tournament. If a team earns a bid at the AZ Region Boys Qualifier and then pulls out of the BJNC they will forfeit the BJNC entry fee (\$1000) to USA Volleyball (if it is past the entry deadline) or the Arizona Region (if the deadline has not passed) and will be subject to sanctions imposed by USA Volleyball and/or the Arizona Region.

☐ **Teams may only play in the AZ Region Boys Qualifier with players that will be attending the BJNC tournament with this team.** Sanctions may be imposed on the player(s), the coaches, the team, and/or the club by USAV and/or the AZ Region if players drop from this team leaving it unable to attend or reduces the competitive level of the team after qualifying. Teams that forfeit matches or disqualify themselves in the AZ Qualifier to avoid finishing in a qualifying or alternate position or teams that turn back a bid earned at the AZ Region Boys Qualifier are subject to sanction by the Arizona Region. The sanctions for all above may be financial and/or participatory and will carry over to the next season, if applicable.

☐ **Bid Awards:** The team that places first in each age division will receive the American bid to the Boys JNC. The team that places second or third are designated as alternates and are required to remain committed to attend the BJNC until the ALL the reallocation and At-Large bids have been filled and no Arizona teams may advance further. Any team that finishes in an alternate position in the AZ Qualifier, does not hold any bid, and passes on a bid that comes to the Region will be sanctioned by the Region. The sanction may be financial and/or participatory in nature and will carry over to the next season, if applicable.

☐ **Frozen Rosters** - once a team accepts a bid in the AZ Region Boys Qualifier all players on the tournament roster are frozen to the qualified roster. The players may not attempt to help another team (even within the same club) earn a bid at a National Qualifier. The players are not eligible to be released to another club to play at the BJNC or other season ending event.

☐ **All Qualifying Teams:** The 2026 Junior National Championships Entry must be completed in AES and the Entry Form and Fee submitted to USA Volleyball **within 10 days of qualification.** All Alternate Teams must enter AES in the American Division and submit the BJNC entry form and \$1000 entry fee (payable to the Arizona Region) to the AZ Region Office within 10 days of qualification. The entry fee will be paid by the club in AES upon a bid acceptance and the check will be destroyed by the Region OR the Region will deposit the check in the event the club withdraws from the BJNC. USAV will change the division level in AES if the team ultimately receives a bid in a higher level of play.
