COMMITMENT AND EXPECTATIONS

I, the parent/guardian of the above-noted player, have received the Fees/Tournament Schedules and Player/Parent Handbook outlining policies and expectations. I understand that participation is limited and that others were denied a position by our acceptance of a position on a team.

I agree that, having been selected for a team, I commit to the 2025-2026 season. I understand that players are permitted to commit to and play for only one club/team in each club season per the regulations adopted by the AZ Region of USA Volleyball. The club season officially ends after the junior national tournament is completed in June/July 2026 (even if the team for which she was selected is not competing at nationals).

I acknowledge, understand, and agree that playing time, selection to, and maintaining a position on a specific team are at the discretion of the coach and academy administration. Promotions and demotions are possible depending on the player's development and commitment, coachability, behavior, performance, payment standing, etc.

I have read all the materials and understand the time commitment involved in practice and tournaments. Starting in August, I agree to provide transportation for my athletes to attend practices and travel to regional tournaments, typically one or more per month.

I agree that traveling is necessary if our team competes in out-of-state tournaments, and we must be available to play on all days of such tournaments. We will handle all coach travel and accommodations for select, elite, and legacy teams in 2025-2026, included in the season fees. Nationals and any other out-of-state tournaments, along with post-season beyond what is included in the season fees, will be at the expense of the athlete, including coaches' fees, travel, accommodations, registration, and administration. Parents are responsible for lodging, travel arrangements, food, and other expenses for their athletes and families while traveling.

I agree that if, for any reason, our athlete does not abide by the rules and regulations of USA Volleyball, OVA has the right to remove the athlete from the team and the program, with all dues being paid in full. These violations are basic:

- Using illegal drugs, alcohol, tobacco, or vaping at any time.
- Allowing yourself to be in a situation where you are accused of/arrested for an illegal activity.
- Missing practice (unless excused by the Coach).
- Poor Sportsmanship
- Harassment (Verbal/Physical/sexual/etc.) of another athlete or community member.
- Electronic communication (Instagram, X, Facebook, etc.) should be positive and never negatively reflect on other teammates or coaching staff. If it is not favorable, don't post it.
- Do not prioritize your team over your own needs and gains. Always prioritize "we" over "me."

FINANCIAL OBLIGATION AND PAYMENT POLICY:

I understand that I am responsible for all club fees for the entire club season determined by the team our athlete was selected for, even if we choose not to participate in the whole season. Quitting the team does not release me from my financial obligation.

I understand a nonrefundable deposit (commitment fee) is due the day of tryouts if your athlete is selected for a team to secure a spot and will require upfront payment through cash/check or an automatic payment plan via our website.

I acknowledge that I will be enrolled in the Automatic Monthly Payment Plan for the balance of the club fees due when I make the commitment fee payment noted above. A pay-in-full option is also available with a discount applied to the club year cost. In the event of a medical outbreak (ex/COVID-19), I understand no refunds will be issued. Declined payments will be reprocessed automatically five days after the decline.

I acknowledge that club fees not paid by April 10/May 10, 2025, will accrue a 2% monthly finance charge on the outstanding balance until all fees are paid in full. Further, I agree to pay any collection costs and attorney fees incurred on behalf of the club to collect unpaid club fees. Adjustments will be made to a club fee balance to the extent possible in the event of a player's injury or a job relocation requiring the player to move out of state.

I acknowledge that it has a "NO PAY, NO PLAY" policy.

I acknowledge that for families where parents are separated or divorced, it is the responsibility of the authorizing parent/guardian to set up the Automatic Monthly Payment Plan and to collect from the other parent. OVA will not act as a mediator when collecting club fees. If the account is not resolved promptly, the authorizing parent's information will be submitted to a collection agency. Upon request, if a split payment is required, we can create custom plans for both parents.

I have read the above items (including the Fees/Tournament Schedules and Player/Parent Handbook) and discussed them with my athlete. I agree to abide by its commitment and policies and will support its participation.
