### Database Inclusion/Exclusion Policy 2020

Provided by the Minneapolis Afterschool Network, **What's Up 612!** is a FREE citywide online resource where youth, parents, educators, youth workers and everyone who knows a young person can find afterschool and summer activities and programs in Minneapolis for **ages 5-24**.

What's Up 612! seeks to make a positive difference in people's lives by strengthening the way people throughout Minneapolis access children and youth programming and activities. The What's Up 612! database contains information about programs and activities that keeps Minneapolis children and youth safe, inspired to learn, and prepared for the future.

#### SHOULD INCLUDE:

- Providers should serve children and young people within this grade/age range: grades K-12 and/or ages 5-24.
- Providers services can include, but not limited to the following formats:
  - School-age care
  - Ongoing programs with registration
  - One-time activities
  - Camps
  - Drop-in sites
  - Mentoring
  - Dedicated youth employment, entrepreneurship, internship opportunities
- Providers should be:
  - Private, nonprofit 501c(3) organizations that offer free or low-cost youth activities to the community at large (not just to members).
  - Other nonprofit organizations that offer free or low-cost youth activities to the community at large (not just to members).
  - Local, state, and national elected officials and government offices and quasi-public agencies.
  - Advocacy groups and community coalitions.
  - Faith-based organizations (churches, synagogues, temples, etc.) offering youth activities to the greater community and not confined to their own membership or congregation.
  - Public educational institutions and school districts.
  - For-profit organizations providing health or social services not adequately met by other resource listings.
  - For-profit organizations that offer free service, scholarships, reduced fees, sliding fee scale, or that accept Minnesota Afterschool Advance as payment.
  - For-profit organizations that meet court diversion requirements.
  - Organizations under government or nonprofit contracts.

MAY INCLUDE AT THE DISCRETION OF THE MINNEAPOLIS AFTERSCHOOL NETWORK:

- Private educational institutions.
- Private medical or mental health clinics.
- Clubs with an emphasis on health and human services.
- National or regional organizations that offer socially beneficial services meeting the Inclusion/Exclusion criteria.

EXCLUDE:

- This policy does not prohibit the inclusion of any program that targets services based on age, gender, health, disability, or other characteristics designed to meet the special needs of targeted populations. However, the program must be open and accessible to all people in those targeted populations.
- Organizations that deny service on the basis of race, sexual orientation, religious belief, or national origin.
- Organizations that violate local, state, or federal laws or regulations.
- Organizations that misrepresent their services in any way.
- Home-based, unregulated businesses.
- Private individuals and/or practitioners.
- Services, such as early childhood, social services, general jobs available to youth and adults, adult and senior programming (25+), volunteer opportunities.
