## President Report for AGM

- Overall it was a good season, I would like to thank all of the coaches, convenors and
  volunteers that stepped up and helped this past season. Hopefully we can fill the vacant
  spots on the executive board tonight.
- The Regional team was a success in the end, NorMan region has to be better prepared, but the regional teams should help the northern communities be more competitive moving forward in the years to come. Hockey Manitoba is looking at expanding the program from U13 only to U11, U13 and U15 for next season.
- The audit was completed and nothing stood out, other than the lack of paperwork with the previous Treasurer. Moving forward, with Kobelka & Co in the Treasurer position doing the books that will improve, and we will also be having an audit every year now.

The Pas Minor Hockey Association - Treasurer's Report

The accounting records have been complete up to April 30, 2025, with the exception of the April bank reconciliations as we have not yet received those bank statements yet.

TPMHA was in a good financial position as of April 30 with a total of \$217,000 of cash and investments available. This includes \$30,000 in the Legacy Fund and \$25,000 in low risk Guaranteed Income Certificates.

TPMHA had very few payables at April 30 as all bills and payments have been kept up with on a regular basis.

At April 30, 2025:

#### Revenue - total \$278,000

- Registrations for the 2024/2025 season were \$112,224 which includes fees, raffle tickets, volunteer fees, jersey deposits, and regional hockey association fees.
- \$12,000 of discounts were taken advantage of in the year, and \$18,000 were given in various refunds in the year (registration refunds, volunteer refunds).
- All tournaments brought in entry fees of \$23,000 and revenues from the tournaments were \$27,000.
- Rep fees of \$28,000 were collected in the year, with \$11,000 of them being refunded to date.
- LiveBarn continued to be a good source of income for the year, bringing in \$12,000 note there is one quarter that we are still waiting to receive.
- Donations, tournament advertising, merchandise sales and fundraising brought in a total of \$102,000 a round of applause for all volunteers who made the efforts to raise these funds

#### Expenses - total \$258,000

- Entry fees into tournaments cost a total of \$30,000
- To run our own tournaments, it cost us \$42,000
- Fundraising expenses totalled \$29,000
- Our teams were able to give back to the kids by purchasing team entertainment and swag of \$26,000 in the year
- Our remaining expenses include Hockey Manitoba/Canada fees of \$15,000 and general expenses of \$113,000
- Of the \$113,000 in general expenses, some of our larger expenses include ice rentals (\$50,000, note we are still awaiting the April ice rental fees), Jersey expenses (\$15,000), volunteer refunds (\$12,000), and referee expenses and reimbursements (\$7,000)

Overall, there was a SURPLUS of \$20,000 for the 2024/2025 season. This may change slightly, as we are still waiting to receive a handful of outstanding receivables and payables.

#### **TEAMS**

As you flip through each individual teams' income statement, you will notice small deficits and surpluses throughout.

These figures may change slightly, as we receive the final information from Aprils' bank statements.

\*\*You will note, U15 is reporting a large surplus as at February 28<sup>th</sup>. I am still waiting for team records to be received to complete the bookkeeping from March to April. I do anticipate a final small surplus or deficit to be reported.

Overall, the year operated as anticipated, I did not have any unexpected expenditures that arose throughout the year. I look forward to continuing and improving the management of financial information at TPMHA by implementing more consistent record tracking, training of volunteers, and consistent oversight.
