Equipment locker is somewhat organized but need to work on permanent organization in the future. Currently Items are at least separated in different totes.

Equipment questions have quieted down

#### Suspensions

Steve filled everyone in on the player that was suspended from 18U level

- Dad sent Steve back an email disclosing that his child has a medical designation that he does not process things as other kids do (Mental Retardation was the term the dad used) and said that we are discriminating against him.
- Dad did not disclose this information on child's registration in the field that asks if there are any medical concerns that we/coaches should be aware of
- Steve brought this issue to the SAM board, and they were going to handle it
- SAM Board drew up a letter to send to the dad To uphold the suspension of MEAHA of 10 games and a 5-game suspension in addition to the initial 10 games

*Brandon Brewer*: Ejected from 12U game in Auburn - December 13<sup>th</sup> he is suspended 30 days from all USA Hockey Events that fall under MEAHA at any arena. MEAHA emailed him the letter notifying him of this.

John Paige: Booing children of an opposing team at a 12U game in Auburn – Alex Netten (MEAHA Rep) mailed him a letter stating he was suspended 2 home games

- He reached out to Steve via email stating he didn't understand why he was getting suspended because he didn't get ejected during the game.

- Steve responded and explained to him that because the Hockey Steering Committee was notified that he was verbally abusive to officials and booing the opposing team while they were getting medals. Steve also let him know that if he would like to appeal, he can reach back out to the Hockey Steering Committee.
- We have not gotten a response yet.

MEAHA (Alex Netten): Not present but emailed Steve his updates as follows:

Referees:

Reimburse \$100 for officiating for certain things accomplished

Maine Junior Black Bears reimbursing the remainder of their fees.

Something we may want to investigate – not sure what that would cost?

Kristen reaching out to Jesse (referee head) asking when the class would be in our area

Try Hockey for free:

There is another day coming up in February

Disciplinary Actions by MEAHA so far this season:

75% of them have been parents and coaches.

Rostering:

There have been kids that have been playing for different associations (this cannot happen).

This hasn't been happening for any of our players that we know of.

Scores:

Scores are not being updated in a timely manner from other organizations (not a problem for our organization)

**MEAHA** tournament:

As of last night 12/18, they only had 5 organizations had responded to their request for an answer to whether their organizations are going to join the MEAHA tournament
