

Package Travel and Event Information: 4Islands MTB Croatia

Travel Destination	<p>4Islands MTB Croatia is a four-stage mountain bike race held on the following four Croatian islands in the Adriatic Sea: Krk, Cres, Lošinj and Rab, Croatia.</p> <p>Traveler can book the entry for the Event and other services, such as accommodation for her/his team and additional accommodation for a person who is not attending in the mountain bike cycling event (the "Supporter"), as a package travel, choosing from different categories of services as described in this document and detailed during the registration process. Place of accommodation depends on the selection of the Traveler.</p>
Itinerary and periods of stay	15.-21.4.2024., 6 nights
Event	<p>The Event is a multi-day mountain bike race held from 16.-20.4.2024., containing five races (prologue + 4 stages) at the following locations:</p> <p>Island Krk - prologue and stage 1 Islands Cres - stage 2 Island Lošinj - stage 3 Island Rab - stage 4</p>
Transport	<p>The Organiser is not offering the transport from your place of residence to the country of the Travel Destination. Only the transport between the event locations during the event itself and back to Baška (island Krk) are included in the Package. The exact location for departure and arrival for these included transports will be communicated by the Organiser separately. The Traveler has the possibility to book additional transport from the last stage (Rab) to Zagreb airport. For this service the traveler needs to pay an extra fee.</p>
Accommodation	<p>Traveler can choose from the following categories of accommodation during the registration process. Detailed description of the accommodation and included services to be found on the website:</p> <p>Hotel accommodation: city of Baška (island Krk), city Mali Lošinj (island Lošinj), city of Rab (island Rab), all the logistics and transfers between islands, as well as the last day transfer to Baška (island Krk) are included in the entry package.</p> <p>Boat accommodation: all transfers during the race are included in the entry fee, boats are stopping at ferry ports at each island. Last day transfer to Baška (island Krk) is included in the entry package.</p> <p>Boat premium accommodation: all transfers during the race are included in the entry fee, boats are stopping at ferry ports at each island. Last day transfer to Baška (island Krk) is included in the entry package.</p> <p>The scope of services depends on the accommodation category the traveler chooses and is detailed for each category in the registration process. The standard of each accommodation package is a double/twin room. Upon availability it might be possible to upgrade it to a single occupancy for an extra surcharge.</p>
Meal Plan	<p>Hotel accommodation: breakfast and dinner at the hotel.</p> <p>Boat accommodation: breakfast and dinner on the boat.</p>

	<p>Boat Premium accommodation: breakfast and dinner on the boat.</p> <p>Lunch: at the respective race venue during the race days for everyone with a race entry package.</p>

Payment Terms:	The payment is only possible by credit card and the payment is due at the end of the registration process. It is possible to choose the payment plan option and make the payment of the travel package in three instalments.
Minimum Number of Participants:	The minimum number is 200 participants/100 Teams.

Termination Right:	The Traveler may terminate the contract at any time before the start of the package in return for payment of an appropriate termination fee, which are stipulated in the Withdrawal Conditions of the Organiser (link to withdrawal terms)
Insurance:	There is no mandatory insurance required. Traveler is advised to seek appropriate travel, accident or other insurance coverage.

Further Information about your rights under Directive (EU) 2015/2302:

Following rights are certain rights with respect to the package travel contract you are about to enter. Detailed description of such rights are enclosed in the Package Travel Conditions provided to you during the registration process for each package travel:

1. There is always at least one trader who is liable for the proper performance of all the travel services included in the contract.
2. Travellers may transfer the Package to another person, on reasonable notice and possibly subject to additional costs, see the Withdrawal Conditions for more information ([link](#)).
3. The price of the Package may only be increased if specific costs rise (for instance, fuel prices) and if expressly provided for in the contract, and in any event not later than 20 days before the start of the Package. If the price increase exceeds 8 % of the price of the Package, the Traveller may terminate the contract. If the Organiser reserves the right to a price increase, the Traveller has a right to a price reduction if there is a decrease in the relevant costs.
4. Travellers may terminate the contract without paying any termination fee and get a full refund of any payments if any of the essential elements of the Package, other than the price, are changed significantly. If before the start of the Package the trader responsible for the Package cancels the Package, Travellers are entitled to a refund and compensation where appropriate.
5. Travellers may terminate the contract without paying any termination fee before the start of the Package in the event of exceptional circumstances, for instance if there are serious security problems at the destination which are likely to affect the Package.
6. Additionally, Travellers may at any time before the start of the Package terminate the contract in return for an appropriate and justifiable termination fee.
7. If, after the start of the Package, significant elements of the Package cannot be provided as agreed, suitable alternative arrangements will have to be offered to the Traveller at no extra cost. Travellers may terminate the contract without paying any termination fee, where services are not performed in accordance with the contract and this substantially affects the performance of the Package and the Organiser fails to remedy the problem.
8. Travellers are also entitled to a price reduction and/or compensation for damages where the travel services are not performed or are improperly performed.
9. The Organiser has to provide assistance if the Traveller is in difficulty.
10. If the Organiser or, in some Member States, the retailer becomes insolvent, payments will be refunded. If the Organiser or, where applicable, the retailer becomes insolvent after the start of the package and if transport is included in the package, repatriation of the Travelers is secured. Organiser has taken out
