



## GHA Board Meeting Minutes

Wednesday, August 14, 2019

1. Call Meeting to Order - President-elect Muzzarelli called meeting to order at 6:00 p.m. Coach-in-Chief Eiland attended via phone.
2. Public comment: - *Members who have comments, questions, or suggestions may do so during this time. All other parts of the meeting are closed to public remarks. If the Board goes into executive session, all others will be asked to step out of the room.*

The new rules plus enforcement of existing rules by referee's is expected, Ken Ostrom (Ref in Chief) has been instructed to pass along this crack down to all his referee's and instructors. Here is an example: any player/coach who argues a minor penalty shall be assessed an additional unsportsmanlike penalty. We basically want to eliminate as much of this type of behavior as we can. I think we can all agree that the whining and complaining is a bad look for us all.
