INTENTION OF PROPOSAL:

- Page 64 indicates that Tier I and Tier II will follow the National Tournament Guidebook, and then further on page 66 lists incorrect information for period lengths and/or round robin overtime.
- There is a discrepancy between league rules and period lengths for 14U Tier II in this section, and then with what PNAHA has listed and what the National Tournament Guidebook indicates. This rule change is intended to align league rules with the state tournament rules (which would default to National Tournament rules for league and state tournaments).
- Round Robin National Guidebook Rules indicate a 10 minute sudden death overtime and then a shootout (all games played to a winner). Current PNAHA rules indicate a 5 minute overtime period and then a shootout.
