If you are coaching 8U or 6U you only need your level 1. When you move to 10U you will need to move forward with clinics.

Sub Goalies- Non national bound teams can sub a goalie for sickness reasons only. Equal level or lower.

If you are national bound, it has to be a lower level goalie subbing.

Player Releases- we are done with player releases.

After December 23, new players are not allowed to play in Districts.

Coaching Clinics-Associations need to check their coaches' clinic status. Any coach who has not completed the clinic will not be allowed on the roster or ice on 1/1/23.

Fox Motors and Rockford are the only 2 teams registered in 16U Districts. Both teams have requested to play each other at the end of December. Teams will play by MAHA rules. Tom brought the motion to allow, Peggy 2nd the motion and the Council voted 12-4-1 to allow the two 16U teams to play early as long as books are checked before the games begin.

Council voted 6-1 to approve the following tryout dates for District 6. MAHA D6 Tryout Rule Effective 4/1/22

1) All tier 1 national bound teams (girls 14, 16 and 19U and boys 15 only, 16 and 18U) team tryouts can begin 48 hours after the last game of USAH Nationals.

2) Teams in Tier I and Tier II non-national bound categories must follow the MAHA guidelines/dates for each age level based on the completion of the MAHA state tournament.

3) All Tier I non-national bound teams (girls 12U and boys Bantam Major and below) can start tryouts the 1 st Monday in May or after for all (fall/winter) regular season teams.

4) All Tier II national and non-national bound tryouts can begin the 3 rd Monday of May or after for all (fall/winter) regular season teams.

5) Border Associations: Jackson, Chelsea, Lansing and Ann Arbor are Exempt from #4.

Mite Jamboree is in the works. Credential book checks dates January 17th GR. January 19th Lansing.
