



GENERAL CONTRACT

CONGRATULATIONS and WELCOME to Force Volleyball Academy!

We, the parents/guardians of _____ (Player Name), have accepted a position on the _____ (Age/Team – Example “15 Travel”) through the remittance of our \$500.00 deposit. We agree to pay Force Volleyball Academy club dues in the amount of _____ (Total Dues – Example “\$1925”). We have carefully read the following information concerning the policies of Force Volleyball Academy.

Payment Policies:

- *We understand that club dues include pre-scheduled group training, use of equipment and facilities, memberships, volleyball for tournaments and training shirts.
- *Travel, non-mandatory apparel, and optional group or private training is not included in the club dues.
- *We understand that we are solely responsible for all fees per the fee schedule. And that the uniform is a separate purchase.
- *We understand that ALL deposits are non-refundable.
- *We understand that ALL monthly club dues are non-refundable.
- *We understand that once a deposit is made to accept a position on a team, if my daughter is unable to play at any time or for any reason (injury, illness, scheduling conflicts, etc.) that I remain liable for my daughter’s total club season dues. Outstanding balances are due within fourteen (14) days of my daughter’s departure from the club.
- *We understand that if a violation of the general contract or the team rules & policies contract results in the dismissal from the club that I remain liable for my daughter’s total club season dues. Outstanding balances are due within fourteen (14) days of my daughter’s departure from the club.
- *We understand that if any payments are late or in default, my daughter will not be allowed to attend any practices or tournaments until payments are up to date.
- *We understand we will be held liable for any costs associated with returned payments, collection of unpaid fees, or any legal action that results as a breach of this contract.
- *Payments can be made by credit card, cash, Venmo or check.
- *Credit card payments can be made via SportsEngine invoices only. One has been emailed to you, any questions please email forcevolleyball31@gmail.com.

Team Rules & Policies Contract

Accepting a position on a Force Volleyball Academy Local, Regional Select, Adidas Select Blue/Black, or Adidas Select team is a commitment by the player and player's parents. Acceptance of the position is a dedicated time commitment regardless of other activities that are occurring during the club volleyball season. Players and parents are aware and agree to the following:

- Force Volleyball players, parents, and fans all represent Force Volleyball. It is expected that players, parents, and fans treat fellow teammates, parents, coaches, officials, each other's schools, and communities with respect.
 - Bullying in any degree or any form (physical, verbal, written or electronic means) is not tolerated.
 - We will submit all required forms and paperwork to the head coach by the first practice in January. All forms can be found on the Force website on the "Membership & Forms" page under the "Resources" tab at the top.
 - o Birth Certificate
 - o Medical Release Form
 - o General Force Contract/Team Rules & Policies
 - We understand that timely attendance at both practices and tournaments is expected. Habitual tardiness or absence, without discussing the situation with the head coach, is unacceptable.
 - All vacations/family events/conflicts scheduled during the season will be given in writing to the head coach by the first practice in January.
 - In the event of an illness or emergency, we will contact the coach immediately at the phone number provided.
 - We understand that if a practice must be missed, we are able to make up the practice with another team on another day.
 - We understand that if a missed practice is not made up, playing time for one match at the next tournament is forfeited.
 - We understand that each player is guaranteed 3 rotations of play per match in pool play of each tournament. Playing time during playoffs or bracket play is not guaranteed.
 - Extended illness or injuries will require a doctor's note or release to resume playing in practices or tournaments.
 - For tournaments, players will arrive 1 hour prior to the start time of the tournament for a proper warm up.
 - We understand that Force t-shirts must be worn for each practice/clinic and as a warm up shirt over the jersey at tournaments.
 - For practices, players are expected to arrive at the gym with enough time to set up nets/equipment before the designated start time.
 - ALL technology is prohibited during practice and tournaments. Any equipment that can take pictures is NOT PERMITTED in any bathroom or locker room.
 - We understand and will adhere to the 24/48-hour rule. Any player or parent concern about coaching decisions must wait until 24 hours after the tournament or practice to be communicated and will be considered a closed issue after 48 hours.
 - o It is not acceptable for a player or parent to communicate with a coach about playtime during the event.
 - o All issues must be addressed in the following order:
 - ♣ Player/Coach
 - ♣ Player/Parent/Coach
 - ♣ Player/Parent/Coach/Administration
 - o Players will be included in every discussion a coach has with a parent. Empowering your daughter to advocate for themselves will help them to become strong young ladies!
 - Force does not provide tape/prewrap/etc. used for preventative injuries. Athletic trainers are only available at some (not all) of the tournament sites.
- We agree to the policies as outlined above. We understand that violations of this policy may result in reduced playing time, suspension from practices or tournaments, or dismissal from the club.
