- **DECLARATION DATE – The highest level at which any athlete (Dev. or Xcel) competes in 1-4 events after February 2, 2026, determines the level at which that athlete MUST compete at State Championships.**

- **Suggested Entry Fees for In-Gym Competitions:**

In Gym Qualifier:

\$50.00 Level 1-5/XB/XS

\$55.00 Level 6-10/XG/XP/XD/XSA

In Gym Invitational:

\$75.00 Level 1-5/XB/XS

\$80.00 Level 6-10/XG/XP/XD/XSA

- **States Entry Fee:**
\$85.00 Levels 1-10/XB/XS/XG/XP/XD/XSA
- **States Team Fee:**
\$40.00 all Levels/Divisions - Top 3 scores for all Dev. Levels and Xcel Divisions.
- **All competitions highlighted in yellow on the MA Qualifying Calendar can be used as qualifiers to State Competitions.** Levels 1-5, Xcel must qualify from an in-state competition highlighted on the MA Qualifying Calendar Schedule, Levels 6-10 may qualify using either an in-state competition listed on the MA Qualifying Calendar or an out of state sanctioned competition. If using out of state competitions as qualification, a copy of the scores as well as the sanction number must be emailed to massusagcommittee@aol.com.
- All Level 4-10, XP, XD, XSA qualifying meets in MA must have a two (2) judge panel.
- **As soon as all of your athletes have qualified to their respective State Championships, please submit the States qualification form to massusagcommittee@aol.com.** Please do not wait until the deadline to do this! Forms that are submitted later than the Qualification Deadline, not completed in their entirety, or not completed correctly, will be assessed a \$5.00 per athlete (max. \$500.00) verification fee. Forms that are submitted on or prior to the Qualification Deadline completely and correctly are at no charge.

- Level 1-3/XB 100% Awards

In-Gym and Outside Venue Invitationals/States – 100% AA of something – does not have to be a trophy. Placements for events (States @ 40% for Xcel as R&P, Invitationals recommended 50%)

- State awards – 35% for events and AA for Levels 1-10; 40% for Xcel

- Individual Event Specialists (IES)

- Mobility through levels 7-9 is an 8.5

- IES gymnasts need to score an 8.7+ twice in any qualifying meet to qualify for states.

- To qualify to Level 9/10 Regionals, an IES needs to score a 9.0+ at states on their respective events.

- There is no opportunity for Level 6, 7, 8 or Xcel gymnasts who are event specialists to qualify to Regionals.

- How to register for MA State Championships?

- Submit your Meet Reservation online at www.usagym.org, then process payment online at www.meetmaker.com. Refunds will only be distributed to scratches that are submitted online in Meet Reservations AND processed via MeetMaker by the entry deadline.



- After hosting a meet (**mobility meets too!**)
 - Return sanction to USA Gymnastics.
 - Copy of page #2 ONLY of sanction and \$2.00 per gymnast payable to USAG Region 6 and sent to Michele Archer - PO Box 294 - Ashburnham, MA 01430.
 - PTF sent to massusagcommittee@aol.com (must be done by the Wednesday following the competition).
 - Publish results to myUSAGym **and Score Cat** within 24 hours following the conclusion of the competition.
- Age Groups for all Sanctioned Qualifying Competitions are at the discretion of the Meet Director.
