



RETURN TO PLAY WAIVER AND ASSUMPTION OF RISK AND LIABILITY RELATING TO CORONAVIRUS/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely dangerous and is believed to be spread from person-to-person contact. As a result, federal, state and local governments and health agencies recommend established guidelines to reduce the risk of spreading the virus. These include requiring social distancing and, in many locations, prohibiting the congregation of large groups of people. These guidelines are for the safety of the public and should be followed. Notwithstanding recommendations and guidelines by these entities, it must be understood that COVID-19 is a continuing threat to the health and lives of the citizens of Wisconsin.

The Pewaukee Basketball Club, Inc. (PBC), in conjunction with all leagues (WYBL, YGSBL, LCGBA, MGBCBL), has put in place preventative measures to reduce the spread of COVID-19. However, it is understood that the PBC cannot guarantee that you or your child(ren) will not come into contact with or become infected with COVID-19. Your mere physical presence at basketball related activities could increase your risk and your child(ren)'s risk of contracting the virus. Notwithstanding the risk of infection, I, on behalf of myself / myself and my minor child(ren), wish to voluntarily attend and/or participate in PBC basketball activities. These basketball activities include, but are not limited to workouts, summer camps, open gyms, organized practices, scheduled league and tournament games, and other training or team activities, and possibly travel to other facilities not under the control of the PBC. In consideration of being allowed to participate in any way in any basketball activities, I, and/or my minor child(ren) state as follows:

1. I understand that although the PBC has taken precautions to provide proper organization, supervision, instruction and equipment for the services being offered, it is impossible for the PBC to guarantee absolute safety from infection by COVID-19. Also, I understand that I share the responsibility for safety during all activities, and I assume that responsibility. I will make my instructors aware to the best of my ability of any questions or concerns regarding my understanding of safety standards, guidelines, procedures and my ability to participate at any point during any basketball activities. I will also take steps to ensure my own health/health of my child(ren) before the child participates in any basketball activities.
2. I understand that risks during any basketball activities include possible exposure to COVID-19. In addition, risks of any basketball activities include, but are not limited to loss or damage to personal property, injury, permanent disability, fatality, exposure to inclement weather, slipping, falling, insect or animal bites, being struck by falling objects, hypothermia (cold exposure), hyperthermia (heat exposure), and that severe social or economic losses that may result from any such incident. I also understand that such accidents or illnesses may occur in remote areas without easy access to medical facilities or while traveling to and from any basketball sites. Further, there may be other risks not known to me or not reasonably foreseeable at this time.
3. I assume all the foregoing risks and accept personal responsibility for any damages due to such injury, permanent disability or death resulting from participation in any basketball activities.

After you have reviewed this Waiver and Assumption of Risk and Liability, and if you understand and agree with its contents, sign below. If you are the parent or legal guardian of a participating child(ren), please read this document to the child(ren), and if you both agree and understand its content, sign below. I voluntarily agree to assume all of the foregoing risks described in this Waiver and Assumption of Risk and Liability and accept sole responsibility for any injury to my child(ren) and myself (including, but not limited to, personal injury, disability or death), illness, damage, monetary loss, claim, liability, or expense of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s participation in any basketball activities.

On my behalf, and on behalf of my child(ren), I hereby release the PBC, its agents, coaches, instructors, volunteers, representatives and board members from any and all claims, demands, and causes of action, whether resulting from negligence or otherwise, of every nature and in conjunction with any basketball activities as set forth above. In addition, signing below this Waiver and Assumption of Risk and Liability, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and/or I may be exposed to or infected by COVID-19 by attending and/or participating in any basketball activities. I understand and agree that this Waiver and Assumption of Risk and Liability includes any Claims based on the actions, omissions, or negligence of the PBC, its agents, coaches, instructors, volunteers, representatives and board members, whether a COVID-19 infection occurs before, during or after attendance at any basketball activities.

I / My child and I understand and agree to the content in this waiver and assumption of risk/liability as it relates directly to me.
