Approval of Minutes

The minutes from the October meeting were approved.

General Update - Chris Johnson

- Introduction of any guests

- Parent Meeting Reminder
 - o 1/9/18 7:00 pm
- Hopkins Baseball Bat Expo
 - o 1/13 6:00 8:00 Lindbergh
 - Fundraising options
 - Team price and backed out what we needed for the sales tax
 - 2018 budget \$500 made on fund raising
 - 1. Price \$279.96 retail \$395
 - 2. Charge players up charge on average of \$10 per bat, charging 5% up charge.
 - 3. The league pays for the batting cages
 - 4. Discount to players even with up charge.
- HBA Tax Filing Status
 - o Discussed alternatives with other baseball leagues and accountants
 - We lost status for non-profit for state of MN which has been reinstated
 - Needs to be registered on an annual basis
- House player fee structure
 - \$300 house fee charged with no payment with installment plan. Brings us to over \$590 which is a high fee for tournament and travel teams.
 - March 1 is the cut off to remove the final payment
 - Tyler We won't have the try out completed by March 1 and need to consider sending refund checks instead.
 - O Discussed value between tournament and travel teams and determined that it is equal based on the number of tournament games and uniform.
 - Tournament team plays three tournament games

 Final decision is to charge full amount for each player, shutting off last payment for house payments and refunding the third payment for those who did not make the tournament or travel team via mailed check.

- Head Travel Coach Notifications

 - High school 9th grade coach is a potential candidate
 - Coached Hopkins and Edina football as well
 - Could fill in an empty slot if needed

General Discussion Topics – C. Johnson and Board

- Pitch Count
 - See last two pages of meeting minutes
 - Jerry Raise pitch count from 20 to 30 (13-14) adding 10 pitches for each additional level.
 - Allows for increased pitch practice/experience prior to being pulled from mound for a one day rest
 - Pitch counts follow USA baseball pitch count rules
 - 13 year old players
 - Matt It is difficult to teach pitching with these rules to introduce different rules. Suggested
 we increase pitch count to 25 or 30 after a certain point in the year to build up strength in
 the arm. Another suggestion is to increase 14 year olds by increasing by 5 pitches to help
 develop them for the 15 year old team.
 - Tyler We are development team and should increase the pitch count after June 1.
 - Chris We need to look at the science provided by USA baseball.
 - Proposal: June 15th increase pitch count for 14 year olds by 10 at each level to align to 15 year olds.
 - Proposal: Start of season increase 14 year olds by 5 pitches at each level keeping maximum daily at
 95
 - Proposal: Maintain current pitch count and make adjustments during tournaments.
 - Proposal: Increase by 5 pitches during tournament play, discernment is on coaches
 - Motion: Keep pitch count as is during tournament play to protect player arms
 - For 6 vs. Against 7 Motion Doesn't Pass
 - Motion: Start of season increase 14 year olds by 5 pitches at each level keeping maximum daily at 95
 - For 12 Against 1, Motion passes
 - See changes below
