



## 2025-2026 Parent/Guardian Contract

As the parent (s) or guardian of \_\_\_\_\_, I (we) agree to support my (our) athlete throughout the entire season by adhering to the following rules and guidelines:

- Parents will not be able to stay and watch practices.
- I (we) agree to stay positive and encouraging while the athlete is on and off the court.
- I (we) agree to pay the club fees on time to ensure the athlete is allowed to participate throughout the full LHVA volleyball experience.
- I (we) have read and understand the GEVA Parent and Fan Rules.

**Club Fees are Non-Refundable-** The player's commitment to play on a team is an agreement to pay the season in full (\$ 5,200), as set forth in the **14 Purple National 2025-2026 Team Player Commitment Contract**). The payment of fees by each player is necessary to cover the expenses incurred by LHVA with respect to that player's specific team, including tournament fees, gym rentals, qualified and certified coaches, hotel accommodations, training equipment and uniform packages. These expenses will be incurred in full by LHVA regardless of whether an individual player does not complete the season. Accordingly, in the event that a player does not continue to play before all fees have been paid, all club fees are still due and payable regardless of the reason. This fee agreement cannot be canceled, broken or vacated without the full written consent of LHVA's Director. If a player leaves the club during the season for any reason, including but not limited to illness and/or injury, or is dismissed for rule violations and/or disciplinary reasons, fees for the entire season will remain the responsibility of the player and all responsible parents/guardians.

**General Release-** The undersigned hereby releases the Lower Hudson Volleyball Association, Westchester Torah Academy, Level Fitness Pelham, Westchester Day School, employees and volunteers thereof any responsibility should an accident or injury occur to the named participant in the Lower Hudson Volleyball Association 2025-2026 season.

**Hold Harmless Agreement-** This agreement contains a waiver of rights by the people signing it. Please read it carefully. If you have any questions or reservations, please do not sign it.
