## **USL League Two Bracket Challenge Sweepstakes**

**NO PURCHASE NECESSARY TO ENTER OR WIN.**

### **HOW TO ENTER**

You can enter the Sweepstakes by selecting one winner for each match of the USL League Two Playoffs.

Each entrant must then enter each of the following data points to be eligible for prize.

- First Name
- Last Name
- Email
- Date of Birth
- Zip Code
- Favorite USL Club

Maximum limit of one entry per Entrant per email address, regardless of method of entry. All entries must be received by the end of the Sweepstakes Period to be valid. Incorrect or incomplete entries are void. Any attempt to obtain more than one (1) entry per day by using multiple/different email addresses, identities, registrations or logins, or any other methods may void the entries and Entrant may be disqualified from the Sweepstakes. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, sweepstakes entry services) will void all entries by Entrant. other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder.

Consenting to any available opt-in opportunities to receive promotional emails is optional and is not required for participation in the Sweepstakes and will not improve Entrant's chance of winning.

### **WINNER SELECTION**

Entrants will receive one (1) point for each correct pick that is made in each round of the tournament.

At the conclusion of the Tournament, Entrants scores will be calculated, and prizes will be awarded as described below. In the event of a tie, ties will be broken in the following order:

1. Correctly guess the tournament winner
