#### **Old Business:**

*Ice Arena Contract:* Final negotiations resulted in a 3 year contract with marginal increases of \$2,500 per year. 2021 – 2022 season regular ice fee is \$127,000. Discussion took place around the affordability of ice at the increased rates imposed by the Arena Board.

Skills Sessions: Coaching Committee is still working on getting a lead organized for this program.

Background Checks / Safe Sport: Shannon reminded everyone of the timing related to completion of these items. Board roster must be approved before USA Hockey will approve any teams.

Apparel / Accessories: A local vendor reached out and offered to provide an on-line store. Jessica is working out the details, but the store will be available for orders within the coming weeks.

*Jerseys:* Jerseys are scheduled to arrive October 21<sup>st</sup>. Coordinators will be contacting for handling their teams.

Recruitment – Girls THFF: Great turnout. Early results indicate potentially 4 new skaters, mostly 8U age.

#### **New Business:**

Fundraising Events: Heggies Pizza fundraiser will kick off November 15<sup>th</sup>. Same program as prior years, \$3 per pizza sold goes into each skater's account.

*Tournament DIBs hours:* Only awarded one district tournament (PeeWee B). Kellie to evaluate the impact on DIBs hour requirements for next board meeting.
