



# Illinois Youth Soccer Guest Player Permit

For Illinois sanctioned tournaments, this form does not need to be submitted to Illinois Youth Soccer for approval but this form must be completed and submitted to the Tournament with the borrowing team's league roster. For out-of-state tournaments, this Guest Player Permit must be validated by Illinois Youth Soccer Association.

**This Guest Player Permit is for use by the team borrowing the Illinois Youth Soccer(IYSA)/ US Youth Soccer (USYS) registered guest player who has been given permission by his/her IYSA/USYS registered (Lending) Team coach to participate as a guest player in an IYSA/USYS soccer activity (tournament, tryouts, indoor game, etc.) with the Borrowing Team. This Guest Player Permit is valid only for the soccer activity and dates indicated herein. IYSA registered players that participate in soccer activities that are not sanctioned by IYSA/USYS and/or teams that are not currently registered with IYSA/USYS are not covered by IYSA insurance. THIS FORM MUST BE SUBMITTED TO ILLINOIS YOUTH SOCCER WITH A COPY OF THE BORROWING TEAM'S APPLICATION FOR TRAVEL. NO APPROVAL WILL BE GRANTED UNTIL THIS FORM IS FULLY COMPLETED AND SIGNED.**

1. Enter the required information as specified. Use separate form for each Guest Player, activity, date, location, coach, team.
2. The Guest Player must be a currently registered IYSA/USYS player who has been released by his/her registered (Lending) Team coach to play as guest player with the Borrowing Team for the activity indicated. The Guest Player must use the player pass from his/her IYSA/USYS currently registered league team or his/her current IYSA/USYS Tournament Pass.
3. If player is not currently registered with IYSA/USYS, player must obtain a Tournament Pass from Illinois Youth Soccer Association or player's resident USYS state association.
4. List the name of the Borrowing Team's rostered player that is being replaced by the Guest Player.
5. The information on the player's pass must match the information provided in this Guest Player Permit.
