Subject: Membership Registration Fee – Proposed Annual Inflation Adjustment

At a Special Meeting of the Members held on December 12, 2020, the Voting Members approved a motion that Voting Members would vote on any proposed inflation increase to Ontario Soccer's Membership Registration Fees. Annual adjustments would be approved at the Annual Members Meeting (AMM) starting in 2022 for implementation the following year (effective 2023 Outdoor Season and 2023-24 Indoor Season).

It was also agreed that Ontario Soccer will communicate in spring of each year the inflation rate adjustment for the upcoming registration year (i.e. 2023 inflation adjustment would be communicated Spring of 2022).

The 2023 season Membership Registration Fees will increase based on the 2021 inflation rate of 3.4% (Bank of Canada) as follows:
