II. Secretary's Report - Approve Nov 5 and Nov 16 minutes

III. Treasurer's Report

Brad received application for food license, but it isn't due until 30 days before we need it. He will probably get it filed in the next few months so it's ready for 2022.

Discussed additional raffle at the Rotary Cup. Need a parent group to help organize an idea and develop something if we are going to pursue that. Board members need to send Brad their contact information ASAP.

IV. Indoor Winter Programs

Middle school gym is set for soccer Sundays (futsal, mighty strikers, stealth). Ben and Andrew Westphal will coach Mighty Strikers and will ask a couple of high school girls to help out. Joel will be coaching Stealth and Joy will run the Futsal program.

Ben will check on indoor soccer nets (pop-up goals) as they are ripping. Futsal bags are also likely bad. Board approved buying of new nets for indoor soccer. Ben will check on which night, if any, work for soccer pick-up games at the middle school.

V. DIBS Restructuring Update

Still need board liaison for several areas. Will need to nail down who on the board is going to be helping out.

VI. 2022 Season Registration

E-blast went out from Courtney to remind parents to register to get early bird rates before Dec 31. Need another E-blast near close of year.

Ben will get announcement at Middle School and try to get announcement at High school to remind players to sign-up early.

Discussed adding half page flyer to elementary schools for kids to take home. Would discuss both mighty strikers, summer soccer, as well as futsal/indoor soccer. Courtney is going to look into that.

VII. 2022 Calendar

Noel is willing to contact sponsors for banner fundraising in 2022; the program is already set-up with pricing, sizes available and how to place the order with Brushmarks.

We asked Courtney to include all board members to any e-blasts from here on out, to keep everyone in the loop. She will also get the website updated with board members and new positions.

Discussed adding Mighty Strikers parents to e-blast for summer registration information too. Some of their kids will be going into U10's and it's good for all parents to know how our program works as their kids get older.

X. High School Contract Update

We have a contract to 2026 currently with the high school. Henry and Brad will be meeting with Rob to go over the contract today. Will report back at the next meeting.

XI. Annual Admin Assistant Review Date-Dec 7 at 7pm

Zoom meeting scheduled for Dec. 7 at 7pm for Courtney's review. Board is welcome to attend, but only officers (mainly Henry) will be speaking. Board Members need to send thoughts to Henry before Monday night.

XII. Uniform Selection Sub Committee 2022
