Policy Name: Private Lesson Policy

Applicability - This policy shall apply any time a Central Ohio Rowing ("COR") Participant seeks private rowing/coxswain instruction ("Private Lesson") from a COR coach outside of regularly scheduled COR team training activities using COR equipment and facilities.

COR supports the development of its Participants in rowing activities through on water and land-based rowing activities and is willing to make COR's equipment, facilities and other resources available for Private Lessons in accordance with this policy.

Participant - shall mean any athlete that: 1) is a member of COR in good standing (i.e has paid all applicable participant fees and is not currently under any COR suspension or other COR disciplinary action); 2) has signed the U.S. Rowing and Club Release of Liability; and 3) has a current U.S. Rowing membership.

- All Private Lessons using COR equipment and facilities shall only be provided by a COR employed coach unless otherwise agreed to in writing by COR and the Participant and/or legal guardian.
- 2. Each Private Lessons shall be for two hours unless otherwise agreed to by COR and the COR coach. The fees for each Private Lesson shall be Sixty Dollars (\$60.00). The fee covers the cost of the COR coach's time as well as the use of COR equipment and facilities.
- 3. All Private Lessons shall use COR equipment and facilities unless otherwise agreed to in writing by COR and the Participant and/or legal guardian.
- 4. All Private Lessons shall occur outside of regularly scheduled COR team activities, including but not limited to regularly scheduled team practices, conditioning sessions, regattas and the like. The schedule for any Private Lessons shall be agreed to by COR, the COR coach and the Participant and shall not interfere with COR's use of COR equipment and facilities.
- 5. All Private Lessons shall take place at Griggs Reservoir unless otherwise agreed to in writing by COR. In the event a Private Lesson takes place at any other location than Griggs Reservoir and transportation any COR equipment to another location is required, Participant shall be responsible for all costs incurred to transport any COR equipment to the alternate location and back to the COR boatyard at Griggs Reservoir.
- 6. Prior to taking any Private Lesson, the Participant, and if Participant is under the age of 18 Participant's legal guardian, shall be required to certify on the COR website that they have read and accept the terms of the COR Private Lesson Waiver of Liability. Participant will not be permitted to participate in a Private Lesson if the on-line Private Lesson Waiver of Liability has not been executed.
- 7. A COR coach shall be required to be present during any Private Lesson when Participant is using COR equipment on the water, accessing the COR boatyard and/or accessing COR dock at Griggs Reservoir.
- 8. If Participant is using one of COR's single sculls for Private Lessons, at least one parent or legal guardian must be present at all times during the Private Lesson when the Participant is taking

- the Private Lesson. A parent or legal guardian must be present even if the Participant has turned 18 and legally considered an adult.
- 9. Participant shall become familiar with and abide by the rules of the waterway and shall not be permitted to participate in Private Lessons until such time as Participant is knowledgeable of such rules.
- 10. The COR Code of Conduct Policy shall apply to all Private Lessons.
- 11. Participant's participation in Private Lesson program is at the discretion of the COR Director of Rowing and the COR coach that will be providing the Private Lesson(s).
- 12. A violation of the Private Lesson policy by a Participant may result disciplinary action including but not limited to the removal of the Participant from the Private Lesson program.
- 13. COR may revise, suspend or terminate the Private Lesson program at any time for any reason.
