#### 4. Old Business:

- a. Sponsorship/Naming Rights Joel
  - Parks and Rec department gave their plan for BIG to the city council with the expectation that they would vote on funding at the next city council meeting.

- b. Treasurer Dan
  - i. March financials show a loss of \$49k, due to me paying the November & January ice bills before month end. We had not received the payments from the associations, but the city was looking for the payments. We have since received all of November and 2 out of the 3 associations for January. So we are showing \$37k of income in April so far.
  - ii. Current cash balance as of today is right at \$100k.
  - iii. We currently have due from the associations \$97k for ice, and we owe the rinks \$115k. So we will see that bank balance go down another \$20k by year end.
  - iv. Estimating no much for remaining income/expenses, That will put us at \$10k income for the year.
