*Over Time – 1 minute Sudden Victory, then one 30 second Ultimate tiebreaker period

*Head gear & singlet suggested but not required

*Note: Every effort will be made to separate wrestlers by weight and age, but we reserve the right to make a one division adjustment if necessary and reasonable.
